

# TELECONFERENCING GUIDELINES FOR PUBLIC PARTICIPATION IN THE COUNTY OF ALAMEDA CIVIL SERVICE COMMISSION REMOTE MEETINGS

## In Person Participation Prohibited

Due to the public health emergency, the County of Alameda has made several changes related to the Civil Service Commission meetings to protect the public's health and prevent the Coronavirus disease (COVID-19) from spreading. The Civil Service Commission meeting room is closed to members of the public and non-essential County personnel. The Civil Service Commission has made the findings required by the Brown Act, including AB 361, to continue holding meetings by teleconference (remotely). The public may observe and address the Commission in meetings in the following ways:

## Remote Viewing/Listening

## Public Comment via Teleconference

Members of the public may address the Civil Service Commission on a matter on the agenda or during the Public Comment portion of the meeting on a matter not on the agenda but is an issue within the Commission's subject matter jurisdiction.

- If you are calling in: dial \*9 to raise your hand to speak. When you are called to speak, the host will unmute you to enable you to speak.
- If you decide not to speak, you may hang up and dial back into the meeting Or, simply notify the Conference Host that you do not wish to speak when you are unmuted and asked to speak.
