BURN PATIENT CRITERIA

- INTRODUCTION -The intent of this policy is to transport patients with critical burns, who have a manageable airway, directly to a facility that is staffed and equipped to care for the medical needs of the patient, bypassing other receiving facilities
- 2. BURN PATIENT CRITERIA (from the American Burn Association Burn Unit Referral Criteria)
 - 2.1 Partial thickness burns greater than 10% total body surface area
 - 2.2 Burns that involve the face, hands, feet, genitalia, perineum, or major joints
 - 2.3 Full thickness burns in any age group
 - 2.4 Electrical burns, including lightning injury
 - 2.5 Chemical burns
 - 2.6 Inhalation injury
 - 2.7 Burn injury in patients with preexisting medical disorders that could complicate management, prolong recovery, or affect mortality

3. **DESTINATION**

- 3.1 **Adult patients** who meet burn patient criteria 2.1-2.7 may be transported directly to an outof-county to a burn center (see #5 below) Minor to moderate burn patients will be transported to the closest, most appropriate receiving hospital
- 3.2 **Pediatric patients** may be transported to Children's Hospital or to a closer out-of-county burn center
- 3.3 Exceptions:
 - 3.3.1 **Unmanageable airway** transport to the closest basic ED. The patient requires intubation and the paramedic is unable to intubate; and/or, an adequate airway cannot be maintained with B.V.M. device
 - 3.3.2 Patient meets Critical Trauma Patient Criteria "Physiologic" or "Anatomic" transport to the closest most appropriate designated trauma center
- 4. **BASE CONTACT** Base Physician contact is required:
 - 4.1 If the patient meets "Burn Patient Criteria" (2.1 2.7) but the paramedic is requesting transport to a basic ED
 - 4.2 During an MCI if more than 2 critical burn patients are being transported to a burn center to verify bed availability
 - 4.3 If the patient requires medical treatment not covered in policy
 - 4.4 Any time patient care would benefit from consultation with the Base Physician

BURN PATIENT CRITERIA

5. OUT-OF-COUNTY TRANSPORT

- 5.1 Do not transport to an out-of-county hospital without first confirming bed availability. This can be done through the appropriate dispatch center or via land-line from the field
- 5.2 Contact the Base Physician if medical consultation is needed
- 5.3 Consider EMS Aircraft transport for land transport times greater than 45 minutes
- 5.4 Give a brief report to the receiving facility including ETA
