An application for a Compostable Materials Handling Facility Permit (Solid Waste Facility Permit - SWFP) for Altamont Landfill Resource Recovery was deemed complete and correct on March 13, 2017 by Alameda County Department of Environmental Health, the Local Enforcement Agency for CalRecycle. This meeting is for all interested parties to provide comments on the proposed SWFP. Interested parties may ask questions and provide comments. Comments may be submitted prior to the meeting, directly to Ms. Jane Auyeung or Ms. Wing Suen by postal mail, email, or fax. The meeting is strictly informational and no official decision will be made at the meeting regarding the formal determination on the CMHF permit application.

Proposed Compost Facility conditions include the following:

- A permit will be issued for the compost facility separate from the landfill operations;
- Use of Covered Aerated Static Pile (CASP) technology to receive, process and compost with a daily limit of 500 tons of materials such as: green materials, clean dimensional lumber, agricultural materials (e.g. grape pomace & animal manure), residential & commercial food waste, mixed solid waste – organics diverted from Municipal Solid Waste (MSW), and digestate from anaerobic organics operations at the facility.
- Allow 83 vehicle trips per day.
- Hours of Operation: Public Hours: Monday – Friday, 6 A.M. to 4 P.M.; Commercial Haulers: Monday – Sunday, 24 hours; Ancillary Operations/Facility Operating Hours: Monday – Sunday, 24 hours; Closed to Public: Thanksgiving Day, Christmas Day, New Year's Day.
- Process feedstock materials within 72 hours from receipt.

Any appeal will be processed in accordance and pursuant to Public Resource Code sections 44307 and 44310(PRC §44307). Appeals can only be made after the decision to issue or deny the permit has occurred.
