The Alameda County Department of Environmental Health, Office of Solid/Medical Waste Management, Local Enforcement Agency (LEA) for the Department of Resources, Recycling and Recovery (CalRecycle), has received and accepted for issuance per Title 14 California Code of Regulations (CCR) Section 18104.2, a Registration Permit Application for California Waste Solutions Wood Street Recycling Facility.

Permit Description:

California Waste Solutions, Inc. submitted a registration permit application for a new Medium Volume Transfer/Processing Facility that will accept and process up to 100 tons per day of commercial and residential recyclable material. The days and hours of operations will be 7 days per week, 24 hours per day and is not open to the general public. The facility size is 1.53 acres and includes an operating area of 1.22 acres. The registration permit will be issued five (5) days from finding the application complete and correct, on or around March 5, 2018.
