## Table 4.2: Advanced OWTS Construction Permit Issuance Process (MINIMUM FEES: \$1,0111)

A Construction Permit must be obtained from ACDEH for all new and replacement OWTS's and major repairs to existing OWTS's. The Permit must be obtained subsequent to Final Building Plan Approval and prior to installation of the OWTS.
