SUBJECT: PROPOSED FY 2021-22 BUDGET WORKGROUP MEMBERSHIP

DISCUSSION/SUMMARY

On December 15, 2020, your Board approved the Fiscal Year 2021-2022 Budget Strategy. The Budget Workgroup, chaired by Supervisor Carson, provides input and advice on budget balancing strategies and developing the proposed budget. The proposed membership list for the Fiscal Year 2021-2022 Budget Workgroup appears in Attachment A and continues to include representatives from your Board, Agency/Department Heads, community-based organizations, labor leaders, and other stakeholders.

SUMMARY

The public health emergency continues to evolve and has challenged us to reimagine our processes amid unprecedented budgetary constraints. With input and guidance from the Budget Workgroup, we will continue to explore budget balancing strategies to help preserve our ability to remain flexible and resilient as the demand for County safety net and other services increases.

The County continues to face significant challenges as we work to protect the health and safety of our residents. With your Board's leadership and the efforts of Agency and Department Heads, the Budget Workgroup, legislative advocates, and other stakeholders I am optimistic that by continuing to exercise fiscal prudence and careful stewardship of our County's limited resources, we will achieve a balanced budget for FY 2021-22 that continues to serve the diverse needs of our communities.

FINANCING

No additional appropriations are required, and there will be no increase in net County cost.
