SUBJECT: ADOPT A SALARY ORDINANCE AMENDMENT TO UPDATE SUBSECTION 1-1.1 TO INCREASE SALARIES

FOR UNREPRESENTED CLASSIFICATIONS RELATED TO IFPTE, LOCAL 21, REPRESENTATION UNIT 16 AND CORRECT THE SALARY FOR THE CLASSIFICATION OF DISTRICT ATTORNEY (JOB CODE #0047SE)

**Dear Board Members:** 

### **RECOMMENDATION:**

Adopt a Salary Ordinance amendment to update Article 1, Section 1-1 (Pay Rate Schedules), subsection 1-1.1 to: i) increase the salaries for Unrepresented classifications of Engineering Trainee (Job Code ("JC") #2005NM) and Architect Trainee (JC #2201NM) related to the International Federation of Professional and Technical Engineers ("IFPTE"), Local 21 Representation Unit 16 by three and one-quarter percent (3.25%) retroactive to February 7, 2021 and ii) correct by rescinding the salary increase for the District Attorney classification (JC #0047SE) as approved by your Board on January 12, 2021 of three and one-quarter percent (3.25%) effective February 7, 2021.

### DISCUSSION/SUMMARY:

Historically, the Unrepresented classifications of Engineering Trainee (JC #2005NM) and Architect Trainee (JC #2201NM) located in the General Services Agency ("GSA") and Public Works Agency ("PWA") received the same salary increase as the IFPTE, Local 21, Representation Unit 16. As such, staff recommends increasing the salaries of said Unrepresented classifications by three and one-quarter percent (3.25%) retroactive to February 7, 2021.

In addition, on January 12, 2021, your Board approved a salary increase of three and one-quarter percent (3.25%) effective February 7, 2021 for Unrepresented Attorney classifications within the Department of Child Support Services, Office of County Counsel, Office of the Public Defender, Office of the Alameda County District Attorney and applied the same increase to the following Department Heads: County Counsel (JC #3260SE), Public Defender (JC #3140SE) and District Attorney (JC #0047SE); however, staff recently learned that the District Attorney (JC #0047) classification was included in error. In accordance with Salary Ordinance subsection 3-9.12, the District Attorney's salary increase for Year 2021 is based on the "same percentage increase received by the County of Alameda Board-appointed Public Defender and County Counsel during the 12 months immediately preceding the date of each increase, said percentages to be calculated by the County Administrator and Human Resource Services Director." As such, staff recommends rescinding the three and one-quarter percent (3.25%) increase effective February 7, 2021.

### FINANCING:

Funds are available in the 2020-2021 Approved Budget and will be included in future years' requested budgets to cover the costs resulting from these actions.

## **SECTION I**
