RECOMMENDATION:

- 1. Authorize the transfer of appropriations for FY 2020-21 in the amount of \$2,611,589 in discretionary services and supplies within the various major divisions within the Sheriff's Office to the Sheriff's Office Management Services division; and
- 2. Authorize the Auditor-Controller to make the related budget adjustments.

DISCUSSION/SUMMARY:

The Sheriff's Office needs to make adjustments to our FY 20-21 appropriation based on the priorities and needs of the Sheriff's Office. After the budget was adopted, some services and supplies appropriations were identified that needed to be realigned between the various appropriations within the Sheriff's Office. The transfer of unspent funds from the other divisions to the Management Services Division will be utilized for a number of projects, as well as securing funds for the new computer aided dispatch and records management system (CAD/RMS) to meet the requirements of the Racial and Identity Profiling (RIPA) Act and funding for the much relied upon Aviation Unit.

The Management Services division acts as the support function for the entire agency. This division will be increased by the unspent funds from the other divisions' services and supplies appropriations. This request is for a one-time transfer of appropriations.
