Recommendation:

Adopt a first reading of a Salary Ordinance amendment to establish the position of Director of Interagency Children's Policy Council located in the Health Care Services Agency, to meet the evolving business needs of the Interagency Children's Policy Council (ICPC).

Discussion/Findings:

We are recommending the new position of Job Code 0401SM, Director of Interagency Children's Policy Council based on a request made by Health Care Services Agency in collaboration with the County Administrator's Office to develop a leadership classification to meet the evolving business needs of the Interagency Children's Policy Council (ICPC).

Alameda County ICPC is a collaboration of Alameda County departments and agencies committed to improving outcomes for children and youth. The mission of ICPC is to engage in cross system collaboration by improving interagency communication, develop child friendly policies and practices and initiate systems changes that result in safe, healthy and thriving children and families throughout Alameda County.

Development of this classification creates a unique opportunity for the County to foster interagency communication and collaboration between agencies and professionals at various levels of authority and responsibilities. The position will report directly to the ICPC Co-chairs and will maintain regular communication with the ICPC County Council, the County Administrator's Office and the Board of Supervisors and has administrative and policy development responsibility for ICPC relative to countywide interagency, collaborative efforts which are administered via a multiple County department organizational structure.

Financing:

Funds are available in the 2014-2015 budget appropriation to pay the cost resulting from these actions.
