**SUBJECT:** 2009-12 FY Organized Automobile Fraud Activity Interdiction (Urban Automobile Grant) Program - Request-for-Application

**RECOMMENDATION**

It is requested that your Board:

1. Approve a resolution to "Execute and Submit Grant Award Agreement" in response to the Request-for-Application (RFA) for the 2009-12 FY Organized Automobile Fraud Activity Interdiction (Urban Grant) Program;
2. Designate and authorize the District Attorney, by title, to submit a Request-for-Applications response and execute a Grant Award Agreement.

**SUMMARY**

The California Department of Insurance (DOI) requires an official declaration by the County Board of Supervisors of its intent to apply for funding for the Organized Automobile Fraud Activity Interdiction (Urban Grant) Program for the 3 year period July 1, 2009 to June 30, 2012. Furthermore, the Board is requested to authorize the District Attorney to execute the RFA responses on their behalf.

**DISCUSSION-FINDINGS**


Under the direction of the Insurance Commissioner, the California Department of Insurance (CDI) administers the Organized Automobile Fraud Activity Interdiction Program and the distribution of grant funds to district attorneys for the prosecution and elimination of organized automobile fraud activity. The Legislature passed and the Governor approved the Organized Crime Prevention and Victim Protection Act of 1999. This measure increased resources to be made available for the fight against organized automobile insurance fraud in major urban areas of California.

The new mandate codified Sections 1871.7, 1872.4, 1872.8, 1874.8, and 1874.81 of the Insurance Code and Section 1806 of the Vehicle Code.

FINANCING

The Department will submit a mid-year revenue and appropriation adjustment request upon actual award. No appropriation or revenue adjustment is required at this time.
