SUBJECT: APPROVE AN EXTENSION/AMENDMENT OF MASTER CONTRACT NO. 900538, AND PROCUREMENT CONTRACT NO. 6281, WITH ORACLE USA INC. FOR SOFTWARE LICENSE SUPPORT SERVICES FOR EXISTING PEOPLESOFT APPLICATIONS IN THE AMOUNT OF \$3,918,781 FOR THE PERIOD OF JULY 1, 2017 THROUGH JUNE 30, 2022

RECOMMENDATION:

Approve an amendment to Master Contract No. 900538, Procurement Contract No. 6281, with Oracle USA Inc. (Principal: Mark Hurd; Location: Pleasanton), for the renewal of Software Update License and Technical Support Services provided under Service Contract #3603008, extending the current contract period of December 15, 1998 to June 30, 2017 by five (5) years until June 30, 2022, and increasing the contract amount from \$14,164,360 to \$18,083,141 (an increase of \$3,918,781).

DISCUSSION/FINDINGS:

On December 15, 1998, your Board approved a contract with PeopleSoft USA, Inc. for the purchase and implementation of an Integrated Resource Management System known as Alcolink. In January, 2005, Oracle acquired PeopleSoft and agreed to continue the contract negotiated with PeopleSoft. Extensions and amendments of the Oracle contract to continue to provide annual software license and support services were subsequently approved by your Board on December 13, 2005 and on December 9, 2008. Annual renewal of the software license and support are required to maintain and update County PeopleSoft applications (Financials and HRMS) with the latest fixes, updates, enhancements and telephone support.

On December 14, 2011, your Board approved an amendment of the contract, extending the term up to June 30, 2014. On June 10, 2014 your Board approved an amendment of the contract, extending the term up to June 30, 2017. At this time, we are requesting for an extension of the current contract for five (5) years, expiring on June 30, 2022 and increasing the contract amount by \$3,918,781.

Oracle has agreed to extend the contract for these services with the terms and conditions remaining the same. Extending this contract will allow Oracle to continue to provide uninterrupted software license and support services for the County.

SELECTION CRITERIA/PROCESS:

ITD has determined that the County does not have the resources, knowledge or experience required to provide software license and support services.

On November 19, 2008, ITD completed a Departmental Justification to Request a Waiver of County Competitive Bidding Requirement. The General Services Agency approved this item as a sole-source as per section V Item A, licensing renewal for maintenance of software and operating systems on May 4, 2009. Additionally, SLEB waiver number 3040 was issued by the Office of Acquisition through June 30, 2016. On March 10, 2017 SLEB waiver number 4579 was issued by the Office of Acquisition through June 30, 2022.

FINANCING:

Funding for the remaining contract term is available in ITD's Fiscal Year 2016-2017 approved budget. With your Board's approval, the requested funding for this contract amendment/extension will begin in FY 2017-2018. There will be no increase in net County cost.

5.1 Oracle warrants that the Technical Support Services ordered and provided under this Agreement will be provided in a professional manner consistent with industry standards. You must notify Oracle of any Technical Support Service warranty deficiencies within 90 days from performance of the deficient Technical Support Services.

5.2 FOR ANY BREACH OF THE ABOVE WARRANTY, YOUR EXCLUSIVE REMEDY AND ORACLE'S ENTIRE LIABILITY SHALL BE REPERFORMANCE OF THE DEFICIENT TECHNICAL SUPPORT SERVICES; OR, IF ORACLE CANNOT SUBSTANTIALLY CORRECT THE DEFICIENCY IN A COMMERCIALY REASONABLE MANNER, YOU MAY END THE DEFICIENT TECHNICAL SUPPORT SERVICES AND RECOVER THE FEES YOU PAID TO ORACLE FOR THE DEFICIENT TECHNICAL SUPPORT SERVICES.

6.6 The Provider will not indemnify the Recipient if the Recipient alters Material or uses it outside the scope of use identified in the Provider's user documentation or if the Recipient uses a version of Material which has been superseded, if the infringement claim could have been avoided by using an unaltered current version of Material which was provided to the Recipient, or if the Recipient continues to use the applicable Material after the end of the license to use that Material. The Provider will not indemnify the Recipient to the extent that an infringement claim is based upon any information, design, specification, instruction, software, data, or material not furnished by the Provider. Oracle will not indemnify You for any portion of an infringement claim that is based upon the combination of any Material with any products or services not provided by Oracle. Solely with respect to Separately Licensed Third Party Technology that is part of or is required to use a Program and that is used: (a) in unmodified form; (b) as part of or as required to use a Program; and (c) in accordance with the license grant for the relevant Program and all other terms and conditions of this Agreement, Oracle will indemnify You for infringement claims for Separately Licensed Third Party Technology to the same extent as Oracle is required to provide infringement indemnification for the Program under the terms of this Agreement. 6.7 This section provides the parties' exclusive remedy for any infringement claims or damages.

7. TERMINATION

7.1 If either of us breaches a material term of this Agreement and fails to correct the breach within 30 days of written specification of the breach, then the breaching party is in default and the non-breaching party may terminate this Agreement. If Oracle terminates this Agreement as specified in the preceding sentence, You must pay within 30 days all amounts which have accrued prior to such termination, as well as all sums remaining unpaid for Technical Support Services received under this Agreement plus related taxes and expenses. Except for nonpayment of fees, the non-breaching party may agree in its sole discretion to extend the 30 day period for so long as the breaching party continues reasonable efforts to cure the breach. You agree that if You are in default under this Agreement, You may not use those Technical Support Service ordered.

7.2 You may terminate this Agreement at any time without cause by giving Oracle 30 days prior written notice of such termination. If You end this Agreement as specified in the preceding sentence, You agree You must pay within 30 days all amounts which have accrued prior to the end of this Agreement, as well as all sums remaining unpaid for Technical Support Services received under this Agreement plus applicable related taxes and expenses (if any).

9.2 A party's Confidential Information shall not include information that: (a) is or becomes a part of the public domain through no act or omission of the other party; (b) was in the other party's lawful possession prior to the disclosure and had not been obtained by the other party either directly or indirectly from the disclosing party; (c) is lawfully disclosed to the other party by a third party without restriction on the disclosure; or (d) is independently developed by the other party.

9.3 Subject to the applicable law, we each agree not to disclose each other's Confidential Information to any third party other than those set forth in the following sentence for a period of three years from the date of the disclosing party's disclosure of the Confidential Information to the receiving party. We may disclose Confidential Information only to those employees or agents or subcontractors who are required to protect it against unauthorized disclosure in a manner no less protective than under this Agreement. Nothing shall prevent either party from disclosing the terms or pricing under this Agreement or orders submitted under this Agreement in any legal proceeding arising from or in connection with this Agreement or disclosing the Confidential Information to a governmental entity as required by law. In the event You receive a valid request for Oracle's Confidential Information pursuant to applicable law, You will provide Oracle with reasonable notice of such request and give Oracle an opportunity to object to or limit any such disclosure.

10. ENTIRE AGREEMENT

10.1 You agree that this Agreement and the information which is incorporated into this Agreement by written reference (including reference to information contained in a URL or referenced policy), together with the applicable order, are the complete agreement for the Technical Support Services ordered by You and supersede all prior or contemporaneous agreements or representations, written or oral, regarding such Technical Support Services.

If such event continues for more than 30 days, either of us may cancel unperformed Technical Support Service and affected orders upon written notice. This section does not excuse either party's obligation to take reasonable steps to follow its normal disaster recovery procedures or Your obligation to pay for Technical Support Services ordered or delivered.

14. GOVERNING LAW AND JURISDICTION

This Agreement is governed by the laws of the State of California.

15. NOTICE

The foregoing shall not be construed to limit the rights You may otherwise have with respect to the Linux operating system, third party technology or Separately Licensed Third Party Technology licensed under open source or similar license terms.

17.2 If any term of this Agreement is found to be invalid or unenforceable, the remaining provisions will remain effective and such term shall be replaced with a term consistent with the purpose and intent of this Agreement.

17.3 Except for actions for nonpayment or breach of Oracle's proprietary rights, no action, regardless of form, arising out of or relating to this Agreement may be brought by either party more than two years after the cause of action has accrued.

17.4 Products and Technical Support Services deliverables are not designed for or specifically intended for use in nuclear facilities or other hazardous applications. You agree that it is Your responsibility to ensure safe use of Products and Technical Support Services deliverables in such applications.

17.5 The Uniform Computer Information Transactions Act does not apply to this Agreement or orders placed under it.





