Approve Use of District 1 Fiscal Year 2014 Management Reward Funds

Dear Board Members:

RECOMMENDATION:

It is recommended that your Board approve the use of District 1 Fiscal Year 2014 Fiscal Management Reward Funds in the amount of \$34,250 to support the following non-profit organizations:

- 1. \$3,000.00 to **Livermore High School** (Principal: Livermore High School Agricultural Department, Joe McNealy; Location: Livermore) to support the implementation of the first annual Agriculture Day Event for elementary school students in Livermore.
- 2. \$5,000.00 to the **U.S. Naval Sea Cadet Corps** (Principal: Marcia Burden; Location: Dublin) to support the program for youth ages 11-17 that teaches basic seamanship and develops their sense of self-reliance, pride and patriotism.
- 3. \$20,000.00 to the **Dublin High School Athletic Booster Club** (Principal: Michelle McDonald; Location: Dublin) to support student-athletes at Dublin High School by closing gaps in funding that include trainer fees, team equipment and uniforms.
- 4. \$5,000.00 to the **Mony Nop Foundation** (Principal: Mony Nop; Location: Livermore) to provide scholarships to middle school students that have completed community service programs.
- 5. \$1,000.00 to **Alameda County Meals on Wheels** (Principal: Cindy Houts; Location: Oakland) to support the preparation and delivery of meals every weekday to homebound seniors.
- 6. \$250.00 to the California Association of Local Agency Formation Commissions or **CALAFCO** (Principal: Pamela Miller; Location: Sacramento) to support the delivery of educational and technical resources to Local Agency Formation Commissions (LAFCos).

DISCUSSION:

With the last remaining agricultural science education student program in the Alameda County school system, **Livermore High School** hosted the first annual Ag Day Event for third grade students in Livermore on April 10, 2014. With plans to host this program each year, the Ag Day event is intended to educate young students about agricultural activities, benefits and history in the Livermore Valley and in Alameda County. This experience will begin to instill an appreciation for agriculture and its potential for future careers in this field. The Ag Day event was supported with bus transportation serving the Livermore network of elementary schools and delivering third grade students to Livermore High School.

Established in 1958, the **U.S. Naval Sea Cadet Corps** provides a healthy environment for youth to foster their leadership abilities, broaden their horizons through hands-on training a guide them to becoming mature adults. Located at Camp Parks in Dublin, the objectives of the Sea Cadet program are to introduce youth to naval life, to develop in them a sense of pride, patriotism, courage and self-reliance, and to maintain an environment free of drugs and gangs.

The **Dublin High School Athletic Booster Club** supports athletic and academic achievement in all student athletes; promotes active and involved parent and community leadership; provides supplementary financial support to all Dublin Gael athletic teams; and maintains the history and tradition of excellence in their sport teams.

The **Mony Nop Foundation**'s primary goals are to foster a commitment to community service in middle school students. Upon completion of required volunteer hours, scholarships are awarded to students for enrichment programs in visual and performing arts, sports and athletics, and leadership development.

The Alameda County Meals on Wheels program supports feeding homebound seniors. It delivers more than 2,000 nutritious meals every weekday to seniors and in so doing, ensures that seniors are safe and secure in their homes. This vital service allows seniors to remain in their homes, where they want to be, with dignity and independence.

CALAFCO provides statewide coordination of LAFCo activities, serves as a resource to the Legislature and other bodies and offers a structure for sharing information among LAFCos throughout the state and with other government agencies.

There is \$34,250.00 available in the District 1 Fiscal Management Reward funds.



The United States Naval Sea Cadet Corps, a non-profit 501(c) (3) (#46-5494386) charitable organization that has been committed to serving youth since 1958. The Sea Cadet Corps provides a healthy environment for youth to foster their leadership abilities, broaden their horizons through hands-on training and guide them to becoming young mature adults.

The Naval Sea Cadet Corps (NSCC) is for American youth ages 11-17 who have a desire to learn about the Navy, Marine Corps, Coast Guard and Merchant Marine. Sea Cadets are authorized by the Secretary of the Navy to wear Navy uniforms appropriately marked with the Sea Cadet Corps insignia. The objectives of the Sea Cadet program are to introduce youth to naval life, to develop in them a sense of pride, patriotism, courage, and self-reliance, and to maintain an environment free of drugs and gangs.

Navy Cadets are trained in nautical skills such as knot tying and splicing, signaling, water safety and swimming, first aid, and even fire fighting. Cadets are instructed in military drill and discipline and are taught from a syllabus covering naval history to ship nomenclature. Navy League cadets also tour ships and bases and participate in community events such as parades and fairs. In addition, cadets have the opportunity to participate in weekend long competitions and one week long summer training held on Navy and Coast Guard bases. Week long summer training is comprised of NLCC Cadet Orientation or "mini boot camp" for new cadets, and advanced training for senior cadets.

Sea Cadets come from all socioeconomic backgrounds, and year after year we continue to grow our recruitment and that includes a significant number of Sea Cadets who continue to come from low-income families. A great deal of the mandatory training and activities take place off site and requires transportation to and from training locations. For our current and future low-income Sea Cadets this can be a significant barrier in their participation and completion of the program. In order for the United States Naval Sea Cadet Corps to continue to serve young people regardless of their income level, in an environment free of drugs and gangs, we raise funds annually for this support.

A monetary donation of \$ 5,000.00 to the United States Naval Sea Cadet Corps would significantly contribute to the ongoing success of the program.

Dear Supervisor Haggerty:

I am writing on behalf of the Dublin High Athletic Boosters executive board to let you know that we were forced to cancel our annual Golf Tournament and Dinner/Auction event due to lack of participation this year.

This is event has been a significant annual fundraiser for the Athletic Boosters organization over the past decade. DHS Athletic Boosters supports 22 teams and more than 850 athletes at Dublin High School with funding for such things as student-athlete stipends for all of our teams (to cover costs for transportation, officiating and equipment), awards and honors, and a large share of the stipend for the athletic trainer that is mandated on site during many of our athletic events. We fundraise through a variety of avenues such as fireworks sales, snack bar revenue and parent donations. But the Golf Tournament revenue comes to about a third of our annual budget.

The loss of the Golf Tournament from this year's schedule will cost the Athletic Boosters approximately \$20,000 heading into next year and will impact our ability to fund athletics at previous levels.

We are seeking a donation of \$20,000 to offset our losses in these circumstances and are hoping your office may be able to help us. Any help you might be able to provide would be greatly appreciated.

Alameda County Meals on Wheels' major focus is on fundraising to support and expand the delivery of meals to homebound seniors. Our fundraising activities include:




