Subject: Salaries in the Alameda County Fire Department

Dear Board Members:

### Recommendation:

That your Board adopt salaries in the Alameda County Fire Department for members represented by IAFF, Locals 55A and 55B and Unrepresented Non-Management classifications, effective January 1, 2009.

### **Discussion/Findings:**

The annual salary survey for Fire non-management and management classifications represented by IAFF, Locals 55A and 55B mandated by the Memorandum of Understanding Dispute Resolution Agreement with the two group's results in a 4.35 percent increase for all represented Fire personnel in the Department. We are also recommending a 2.0 percent increase for unrepresented non-management classifications related to SEIU represented job classifications in Alameda County.

In addition, we are recommending two of the following Benefit changes for Fire Personnel: Holiday Pay is increased from 6.17 percent to 6.22 percent and EMT is increased from 4.09 percent to 4.11 percent.

### Financing:

Funds are available in the 2008-2009 budget appropriation to pay the cost of these increases.
