SUBJECT: APPROVE USE OF FISCAL MANAGEMENT REWARD FUNDS

#### **RECOMMENDATION:**

It is recommended that your Board approve the use of \$4,100 of District 4's Fiscal Management Reward Funds to support the following:

- 1. \$400 for Global Glimpse (Principal: Mary White; Location Oakland) to provide sponsorship for an Oakland youth to attend a summer immersion trip;
- 2. \$1,200 to Rowell Ranch Rodeo, Inc (Principal: Russell Fields; Location Dublin) to provide a petting zoo for children and health screenings for everyone attending The Rowell Ranch Event in Castro Valley;
- 3. \$2,500 to Avalon Village (Principal: Jill Cabeceiros; Location Alameda) to provide housing for active adults over 55 years.

#### SUMMARY/DISCUSSION:

Global Glimpse exists to educate young people about the reality of the world that they will inherit. They inspire and empower high school students to become the global leaders of tomorrow through a three week summer experience in a developing country that emphasizes community service, mutual understanding and respect, and college preparation. This program delivers socioeconomic, ethnic and experiential diversity. The student will learn about the developing world, gain deep personal insight and learn diverse perspectives and experiences from peers.

Rowell Ranch Rodeo, Inc has been operating the Rowell Ranch Rodeo for 90 years. This is a week long event for equestrian enthusiasts. This year, the Rodeo has expanded its activities by including health screenings and providing children with appropriate activities.

Avalon Village is a privately funded, non-profit corporation founded to give Alameda County residents both the practical access and the confidence to live their lives in their own homes as long as possible. Avalon uses a concierge system to provide assistance for a variety of everyday needs that make independent living a real alternative to institutional elder care.

#### FINANCING:

There are sufficient funds in District 4's Fiscal Management Reward to cover \$4,100.

### A Lelaind Community (ALC) – Affordable Rental Housing for Active Adults over 55 years old www.ALelaindCommunity.org

A Lelaind Community (ALC) offers homes to formerly homeless adults over 55 years of age. All homes and cottages are in Alameda County. ALC was founded in April 2009 and just celebrated its first year of operation. During its first year, ALC provided housing to eight people. ALC maintains a waiting list of tenants. We currently are accepting applications and intend to move up to five persons. ALC's strategic plan includes providing subsidized housing at more leased locations. Our goal in year one was to open one house with 3 bedrooms and 1 cottage. We succeeded, and recently opened another cottage for rent. The tenant in the cottage had lost her housing, because the building in which she lived was foreclosed and she had barely one month's notice to move. She lived in her car for a short time before renting the cottage that we located.

All ALC tenants have worked for a living in the past. Due to some life-changing event, such as sustaining an injury that was not fully covered by their previous employer or other circumstance such as substance addiction or incarceration, potential ALC tenants have experienced a severe economic loss. They are on a waiting list for housing. In the meantime, they are unable to pay market rents. Thus, they remain homeless or consigned to living in short-term shelter situations. Many yearn to live in a home or apartment. They seek to regain their dignity, to engage in social interaction with other adults, and generally take care of themselves as they did prior to their life-changing event.

All potential tenants are referred to ALC by either a charitable or other social-service organization. Each a prospective tenant must have either with a case manager or housing counselor who guides them. The prospective tenant is interviewed and evaluated by ALC staff and then is offered a housing spot. ALC seeks those over 55 years old who desire to live in a private rented home as a fully functioning housemate. That means the tenant desires to live where there are up to three other adults living. The housemate shares the common space that includes a kitchen, living room, and dining area. Each is responsible for his or her own bedroom. ALC maintains the housing, both inside and the outside grounds. A photo example is included.

ALC's long-term goal is to own and operate low-rent subsidized rental housing for those over 55 years old, who were referred by a case manager. ALC's plan is to own and operate two to five homes in five years. We hope to offer permanent and transitional housing. Living as housemates in a home environment helps our clients recover their sense of self-worth and dignity. We endeavor to give each tenant the sense that they can rely on ALC to act in their best interests at all times.

ALC is a worthy recipient of the available funds, because this elder housing model has proved that it works and can be sustained. ALC also creates earned income by providing services to prospective tenants and to owners with low-income housing tax credits. ALC holds grassroots fundraisers six times per year, at least. Finally ALC is currently seeking to expand its board of Directors to ensure a well-financed second year and many more years of successful operation.
