SUBJECT: APPROVAL OF CONTRACT FUNDING RENEWALS FOR FY 2018-2019
CBO MASTER CONTRACTS FOR SAFETY NET SERVICES

RECOMMENDATION:

- A. Approve contract funding renewals for 49 Community Based Organization Master Contracts as detailed in Attachment A to provide safety net services for the period of 7/01/18 - 6/30/19 with a total amount not to exceed \$23,647,974; and
- B. Approve a federal fiscal year contract (Master Contract No. 900142; Procurement Contract No. 16701) with Lao Family Community Development, Inc. (Principal: Kathy Chao-Rothberg; Location: Oakland) to provide targeted assistance refugee employment services from 10/01/18 9/30/19 in the amount of \$342,997; and
- C. Delegate authority to the Social Services Agency Director, or designee, to sign and execute the contracts under the CBO Master Contracting process.

SUMMARY/ DISCUSSION:

This letter requests action by your Board to approve the annual listing of Community Based Organization (CBO) contracts administered by the Social Services Agency (SSA). SSA is requesting approval to execute and negotiate exhibits for contracts with the Community Based Organizations (CBOs) listed on Attachment A that continue the terms and conditions of their fiscal year 2017-2018 contracts. This arrangement is essential to provide uninterrupted services and

continuity of care to clients. Your Board has traditionally approved this request in order to allow the department to negotiate final contracts with the approved budget allocations for the new fiscal year without negatively impacting the members of the community served by these CBOs.

These contracts include a provision for reduction in funding levels or termination of agreements in the event revenues are less than anticipated or based on actual contract compliance.

SELECTION CRITERIA AND PROCESS:

All of the agreements on the attachment have been previously approved your Board as annual contract funding renewals; the latest date was June 20, 2017 (Item No.3), All were recommended according to the County's contracting policy. These contractors are local nonprofit CBOs and are exempt from County SLEB requirements.

FINANCING:

Financing of the attached listed contracts come from State, Federal and County General Funds included in the SSA MOE budget for Fiscal Year 2018-2019. There is no change to net County cost resulting from approval of funding renewals of these contracts.
