REWARD FUNDS (FMR) FOR SCHOLARSHIPS FOR INDEPENDENT

LIVING SKILLS PROGRAM (ILSP) GRADUATES

### RECOMMENDATION:

It is requested that the Alameda County Board of Supervisors approve the use of District Two Fiscal Management Reward funds in the amount of \$20,000 to provide scholarships for graduates of the Alameda County Independent Living Skills Program (ILSP) Beyond Emancipation.

#### DISCUSSION:

Beyond Emancipation has the 501(c)(3) non-profit designation for the ILSP. The Independent Living Skills Program prepares high school students in foster care for the adult world, whether work or school. Without families to help them with college expenses, many students struggle tremendously to earn a living and stay enrolled in higher education.

The funds requested will supplement other scholarship funds raised for these deserving students. This year the scholarship will be awarded to foster care and probation youth who are earning their high school diplomas or GEDs and who have also completed nine months of weekly Independent Living Life Skills classes in this program.

#### FINANCING:

District Two has sufficient FMR funds to cover this amount.

# Dear Supervisor Steele:

This year Alameda County ILSP will be having its 22<sup>nd</sup> Annual Graduation at the Oakland Airport Hilton on Friday night, June 4<sup>th</sup>. We have 139 foster care and probation youth who are earning their high school diplomas or GED's and who have also completed nine months of weekly Independent Living Life Skills classes in the program. Many have already been accepted into four year colleges including: UC Santa Cruz, Humboldt State, Holy Names College, UC Santa Barbara, S.F. City College, and Cal State East Bay.

All members of the senior class were invited to apply for scholarships by submitting an application, a copy of their transcript, two letters of recommendation, and an essay describing their plans for the future. The deadline for submitting the applications was February 25<sup>th</sup>. Nineteen seniors submitted scholarship applications and their essays were read and scored by independent readers, from the Board of Beyond Emancipation. Those receiving scholarships from ILSP will be announced at the ILSP graduation and they will receive their scholarship after enrolling in college this fall.

For the past several years your office has been instrumental in securing a \$20,000 grant for these scholarship awards. We would sincerely appreciate your help again this year in securing this grant to help these worthy young people pursue their goal of higher education. I am enclosing a copy of the 501©3 letter the ILSP Auxiliary (doing business

as Beyond Emancipation) for your files. Please find attached a list of the names of youth awarded a scholarship and the amount.

I also wanted to take this opportunity to thank you for all of your service to Alameda County as a member of the Board of Supervisors and specifically your concern for youth in the foster care system and those that emancipate.
