**SUBJECT: APPROVE BEHAVIORAL HEALTH CARE SERVICES - SUBSTANCE
ABUSE TREATMENT AND PREVENTION SERVICES - MASTER
CONTRACTS - FISCAL YEAR 2014-15**

RECOMMENDATIONS:

1. Approve procurement contracts with the thirty-two Community Based Organizations listed on Attachment A for Substance Abuse Treatment and Prevention services in the amount of \$24,829,517 for the period 07/01/14 through 06/30/15;
2. Approve the execution of interim contracts while the contracts and exhibits for provisions of services for amounts and time periods noted above are being negotiated for each Community-Based Organization in amounts not to exceed those listed on Attachment A;
3. Exercise the local authority vested in your Board to allow Behavioral Health Care Services to continue Substance Use Disorder programming without conducting a competitive procurement process for programs funded by Substance Abuse Prevention and Treatment funds to ensure continuity of care and prevent disruption in service levels;
4. Approve the waiver of Small Local and Emerging Business requirements for the four providers that are for profit as sub-contracting treatment would interfere with the quality of care: Addiction Research and Treatment, BAART Behavioral Health Services, Lifeline Treatment Services; Successful Alternatives for Addiction and Counseling Services; and

5. Authorize the Director of Behavioral Health Care Services or his designee to execute master contract exhibits on your behalf and submit originals to the Clerk of the Board for filing subject to approval as to form by County Counsel.

SUMMARY/DISCUSSION:

Behavioral Health Care Services (BHCS) requests approval to establish new procurement contracts with the Community Based Organizations (CBOs) listed on Attachment A that continue the terms and conditions of their FY 13-14 contracts. This arrangement is essential to provide uninterrupted services until new exhibits are negotiated. Your Board has traditionally approved this request to allow the department some flexibility in the time frame required to negotiate contracts.

The thirty-two providers being recommended to continue under contract with BHCS deliver a range of services that address substance abuse disorders in the community. The services cover the spectrum of prevention and treatment services including Primary Prevention, transition to treatment, extensive outpatient services, residential treatment, the detoxification and sobering center on the Fairmont campus, services for parolees through AB109 and specialized services for adolescents.

BHCS is requesting that the Board exercise its authority to waive the Small Local and Emerging Business requirements due to the clinical nature of the services being delivered and regulatory requirements that Medi-Cal funded clinical services not be sub-contracted with organizations that settle to cost in the State settlement process.

BHCS is also requesting that the Board also waive the County requirement for a competitive procurement process for services funded through the Substance Abuse Prevention and Treatment Block Grant. Running a competitive process would seriously impact providers' capacity to provide continuity of care to clients. Approval of this recommendation will meet the requirements of the Federal auditors and avoid potential financial penalties.


SELECTION CRITERIA AND PROCESS:

Two of the providers listed are government agencies and are exempt from the County SLEB policy. The selection of many of these providers of AOD services occurred under the former Alameda County Alcohol and Drug Department, and pre-dates the formation of BHCS. All but five of the providers listed on the Attachment A are non-profit CBOs that are exempt from the County's SLEB policy. However, a number of these non-profit CBOs have elected to participate in the SLEB program, and the SLEB certification number is included on the Attachment A for these providers. A public entity, Alameda Health System dba Alameda County Medical Center is exempt from the County's SLEB policy. Addiction Research and Treatment, BAART Behavioral Health Services, Lifeline and SAACS are for profit providers of methadone treatment. Complying with the SLEB requirement that twenty percent of services be sub-contracted to a SLEB would adversely impact the delivery of client services. BHCS requests that the Board allows these providers to continue service delivery under new procurement contracts.

FINANCING:

Funding for these contracts is included in the BHCS FY 2014-15 Budget. Funding sources include Substance Abuse Prevention and Treatment, CalWORKS, State funding, and County General Fund. There is no increase in net County cost.
