SUBJECT: 2021 ALAMEDA COUNTY SUPERVISORIAL REDISTRICTING

DRAFT PUBLIC OUTREACH PLAN AND PUBLIC HEARING

SCHEDULE

RECOMMENDATION:

- A. Receive a presentation and provide guidance regarding the draft Public Outreach Plan for redistricting; and,
- B. Adopt the Board's public hearing schedule for the redistricting process.

DISCUSSION/SUMMARY:

The U.S. Census Bureau is required by Article I, Section 2 of the U.S. Constitution to conduct an accurate population count every ten years. According to the California Election Code, following each decennial federal census, the Board, using that census as a basis, shall adjust the boundaries of the county's supervisorial districts to be as nearly equal in population as feasible. This process, called redistricting, is essential in ensuring that each board member represents roughly the same number of constituents.

As presented at your Board's April 6, 2021 meeting, the state adopted the FAIR MAPS Act (AB 849/AB1276), which revises and standardizes redistricting for cities and counties. The new law eliminates some discretionary criteria and rules and sets the order of priority for mandatory criteria. In addition, the law provides for additional outreach, public transparency, and opportunities for public engagement. Counties must adhere to a set of requirements for the number of meetings, noticing, drafting draft maps, presenting information online, and timelines.

In addition, the state law establishes requirements for public outreach, especially for underrepresented/non-English language minority communities, and specifies how

information about the process is to be disseminated, including that each government maintains a website dedicated to redistricting.

To meet the new requirements for additional outreach, transparency, and public engagement opportunities, Staff has developed a draft Public Outreach Plan that promotes an inclusive redistricting process by providing opportunities for greater public participation.

Public Outreach Plan

The purpose of the Public Outreach Plan is to have a transparent and collaborative process by promoting and encouraging participation by Alameda County residents through:

- A County redistricting website: www.redistricting2021.acgov.org
- Community outreach, including public hearings and training workshops.
- Instructions and a mapping tool to develop and submit Community of Interest (COI) input
- Instructions and a mapping tool to create and submit draft Redistricting Maps
- A public index of all submitted testimony (COI input, draft Redistricting Maps, and recorded or written summaries of public comments and Board deliberations)

The primary portal for information about the redistricting process for the County of Alameda Board of Supervisors is the dedicated website: www.redistricting2021.acgov.org. Information and materials on workshops, hearings, public comments, and mapping will be available, including online redistricting software for the public to develop and submit their Community of Interest and draft Redistricting maps for consideration. The website and all material stored on the website must be maintained for at least 10 years.

To promote equitable engagement to residents throughout Alameda County, Staff recommends investing in programmatic support and multilingual outreach materials for distribution to community groups. The County will provide tools to equip individuals and organizations to advocate for their Communities of Interest effectively. Because the County will develop these universal resources, individuals with a variety of skills/knowledge base should be able to participate in the redistricting process. The materials will be accessible for them to use to educate their members about the redistricting process and offer a straightforward method to act through the Community of Interest and draft Redistricting mapping software. This outreach approach is intended to provide equal opportunity to all, so that some organizations do not have a greater voice than others based upon their capacity.

In partnership with the County's redistricting consultant, as determined by your Board, Staff will coordinate an interactive two-part Redistricting Workshop: 1) an overview of redistricting and 2) a facilitated discussion to assist individuals or organizations in identifying and explaining their Communities of Interest. Participants will be encouraged to submit Communities of Interest through an online mapping tool and corresponding narrative (written) explanation. In addition, for organizations interested in hosting a workshop internally for their members, the Redistricting Workshop video and corresponding toolkit will be publicly available in multiple languages.

As redistricting is inherently somewhat technical, general assistance to the public will be provided by Community Development Agency staff to maximize engagement. Residents who do not have digital access or who do not use the internet will be able to request paper materials, including mapping worksheets. Should it be necessary, and to the extent staff is available, individuals or community organizations who have identified their Communities of Interest can request mapping support from County staff.

NEXT STEPS:

Consider the proposed Outreach Plan and meeting dates, provide guidance to Staff, and adopt the public hearing schedule for redistricting.

FINANCING:

There is no increase in Net County Cost as a result of this action.

VISION 2026:

The redistricting process for the redrawing of Alameda County supervisorial district boundaries will provide fair and effective representation for all residents and meets the Operating Principles of **Equity**, **Collaboration**, and **Access** in support of our shared vision of a **Thriving and Resilient Population**.

Alameda County 2021 Redistricting Public Outreach Plan (Draft)

Purpose

The purpose of this Public Outreach Plan is to have a transparent and collaborative process by promoting and encouraging participation by Alameda County residents through:

- A County redistricting website: <u>www.Redistricting2021.acgov.org</u>
- Community outreach, including public hearings and training workshops.
- Instructions and a mapping tool to develop and submit Community of Interest (COI) input
- Instructions and a mapping tool to develop and submit draft Redistricting Maps
- Public index of all submitted testimony (COI input, draft Redistricting Maps, and recorded or written summaries of public comments and Board deliberations)

Overview

Redistricting

Every ten years, supervisorial districts must be redrawn so that each district is substantially equal in population. This process, called redistricting, is important in ensuring that each Board of Supervisors member represents about the same number of constituents. In the County of Alameda, the Board of Supervisors is responsible for drawing these supervisorial districts. Redistricting is done using U.S. Census data, which is usually released around March 31 of the year following the Decennial Census, but is expected to be delayed until sometime between September 30-October 30 of 2021, due primarily to the COVID-19 pandemic. For the County of Alameda, the redistricting process must be completed by December 15, 2021.

Importance of Redistricting

Redistricting determines which neighborhoods and communities are grouped together into a supervisorial district for purposes of electing a member of the Board of Supervisors for each supervisorial district. Community members have an opportunity to share their thoughts on how district boundaries should be drawn to best represent their community and the County. The district boundaries typically are in place for the next ten years.

Public Participation

The COVID-19 pandemic has affected everyone's lives, including how to reach out to residents, communities, and interested groups in redistricting. Individuals can sign up to receive redistricting updates and meeting announcements at: www.redistricting2021.acgov.org. The public can attend and speak at virtual public meetings and workshops. The public can submit comments, draft maps delineating their community, and redistricting maps in a variety of formats.

Outreach to Diverse and Non-English Speaking Communities

This Public Outreach Plan builds on the partnership and network developed during the 2020 Census outreach, which included a diverse array of community and faith-based organizations serving thousands of residents from every corner of Alameda County. Similar to the 2020 Census outreach, information

toolkits will be made available in English and in the County's "applicable" languages (see discussion below). Information in additional languages will also be made available as reasonably necessary. Local ethnic media outlets will also be utilized in the outreach campaign.

Applicable Languages

Elections Code section 21508(b) of the FAIR MAPs Act requires the Board of Supervisors to arrange for the live translation of public hearings or workshops held pursuant to the Act in an "applicable language" if a request for translation is made 72 hours before the hearing or workshop (or 24 hours before the hearing or workshop if less than 5 days notice of the hearing or workshop is provided). For purposes of Section 21508, "applicable language" means any language in which ballots are required to be provided by the County pursuant to Section 203 of the Voting Rights Act of 1965.

The most recent Section 203 determination for Alameda County requires ballots to be published in English and for these language minority groups: Chinese (including Taiwanese), Filipino, Hispanic, and Vietnamese. For language minority groups having more than one language (for example, Chinese language minority groups may speak Cantonese, Mandarin, or Formosan) the language or dialect to be used is the one most widely used by the County's voting-age citizens who are members of the language minority group. The Registrar of Voters provides election material for the Filipino language minority group in Tagalog and for the Chinese language minority group in Mandarin.

California often requires the provision of ballot measures in more languages than is required by Section 203. Under Elections Code Section 14201, the California Secretary of State requires Alameda County to provide ballots to four additional language minority groups, but only in a limited number of precincts (not county-wide): Korean, Cambodian/Khmer and Panjabi. These are not "applicable" languages for purposes of redistricting.

Staff is exploring how to set up virtual meetings to allow links to language interpreters, which may include American Sign Language, who can simultaneously translate the public hearings.

Information About Alameda County Redistricting

The primary portal for information about the redistricting process for Alameda County is the website: www.redistricting2021.acgov.org. Information and materials on workshops, hearings, public comments, and mapping will be available, including online redistricting software for the public to develop and submit their community of interest as well as draft Redistricting maps for consideration.

Release of 2020 Census Data for Redistricting

The U.S. Census Bureau anticipates a release date of August 30, 2021, for the 2020 Census legacy data for redistricting (P.L.94-171). The State of California will need 30 days to adjust the 2020 Census legacy data to reflect the actual residency of incarcerated individuals. The Board of Supervisors must approve the final Redistricting Plan and maps by December 15, 2021. This provides a short timeframe in which to receive and review proposed redistricting maps. It is important that outreach efforts begin before the State adjusted redistricting data is released, so the public is ready to submit draft redistricting maps in October and November.

Public Access and Outreach

Redistricting Website

The redistricting website will be the primary source to access and disseminate redistricting information and materials. The website will thoroughly inform residents about the redistricting process, direct residents to mapping software they can use to submit proposed communities of interest and draft maps, and where they can submit written comments. The site will also provide a repository of public comments, meeting agendas, recorded meetings, and summary minutes.

Users can access different languages by using Google translator on the website. In addition, the materials and toolkits will be professionally translated into multiple languages and made available on the website.

There will be a soft launch of the website to announce meetings and allow interested persons to sign up to the mailing list. The hard launch of the website will be in July 2021 to encourage participation at workshops and provide a mapping tool for drawing communities of interest areas and draft maps.

Residents who do not have digital access or who do not use the internet can request paper materials be sent to them, including mapping worksheets. Should it be necessary and if staff is available, individuals or community organizations who have identified their Communities of Interest can request mapping support from County staff.

Outreach Networks

Outreach will build on existing organizational networks.

- 2020 Census Partners: a diverse array of community and faith-based organizations serving thousands of residents from every corner of Alameda County. These organizations recognize the importance of civic engagement including Census, voting, and redistricting and have a track record of assisting their unique clients, patients, families, or members in understanding these systems, their rights, and how to participate in these processes. A list of Census 2020 partners is in Attachment A.
- Libraries: Set up Redistricting Stations equipped with a computer and outreach materials to
 encourage patrons to submit Community of Interest and draft redistricting maps using online
 mapping tool. Staff will target Redistricting Stations in areas of the county with lower broadband

- access, though instructions and materials will be made available to all interested libraries systems.
- Civic Organizations and Neighborhood Associations: Including but not limited to League of Women Voters, Rotary Clubs, unincorporated area Municipal Advisory Councils, and community groups.
- Board of Supervisors: In addition to the interactive website and mapping tool, staff will share
 information with each Supervisor's office so they can inform their constituents about the
 redistricting process.

Toolkits

Outreach staff, in collaboration with the County's redistricting consultant, will develop toolkits in multiple languages for organizations to distribute redistricting information to their social networks.

Education and Training Workshops

In partnership with the County's redistricting consultant, staff will coordinate an interactive Redistricting Workshop comprised of two parts: 1) an overview of redistricting, and 2) a facilitated discussion to assist individuals or organizations in identifying and explaining their communities of interest. Participants will be encouraged to submit their community of interest through an online mapping tool with corresponding written explanation. For organizations interested in hosting a workshop for their organization's membership, the Redistricting Workshop video and corresponding toolkit will be made publicly available in the applicable languages (as defined above).

Email Lists

The compiled email lists from the Census 2020 partner network (1500 addresses), 2011 Redistricting (1300 addresses), and City and Unincorporated Area Councils (18 addresses) comprise the initial email list for outreach.

Media

Staff will carry out a multi-faceted communications campaign including:

- o Local media
- o Ethnic media: TV, radio, print, WhatsApp, WeChat
- o Social media: Alameda County's NextDoor, Twitter, and Facebook channels
- o County email lists

Language

Language access in applicable languages will be incorporated into community outreach, specifically:

- Outreach materials (emails, handouts, social media, etc.) will be developed in the languages noted by the Secretary of State and additional languages will be translated, as required.
- Organizations serving communities beyond the applicable languages may apply for a stipend (\$500 -\$1000) from the County of Alameda to translate the Redistricting Toolkit in additional languages. Such translations will be added to the website.
- Redistricting workshops will accommodate small breakout groups with specific language requests.
- Staff will conduct briefings with ethnic media outlets/journalists.

 - As some hearings require a 60-day noticing period, staff recommends selecting all dates at this time (if necessary, Set Times and Special meetings can be subsequently determined)
 - To be hosted virtually and/or in person (dependent on Public Health Order/Closure of County facilities) at locations/districts in the County; any person may provide public input.
- Key dates:
 - Late September Adjusted Census Redistricting Data made available by the Statewide Database
 - Draft map(s) must be made public for 7 days prior to the public hearing where it is discussed
 - December 15 Deadline for final map approval
