**SUBJECT: SUPERVISORIAL REDISTRICTING**

**RECOMMENDATION:**

1. Review Map E\_1 and Map E\_2, each of which propose minor amendments to the Board-recommended proposal (Map E) to adjust boundaries of supervisorial districts, and determine whether to replace Map E with either Map E\_1 or E\_2.
2. If necessary, hold a public hearing on either Map E\_1 or E\_2 re adoption of new boundaries for the five supervisorial districts.
3. First reading and introduction of an ordinance adjusting the boundaries of the supervisorial districts of the County of Alameda, State of California, following the federal decennial census and repealing Ordinance No. O-2002-10 and Ordinance No. 2006-59.

**DISCUSSION/SUMMARY:**

In March, 2011, the Board initiated the redistricting process to adjust the boundaries of the supervisorial districts of the County of Alameda, as required by the Election Code. An Ad Hoc Committee of the Board was formed to develop an open and structured process in which to proceed.

The members of the Board held a series of six public meetings between May 28 and June 10, with at least one meeting held in each of the five current supervisorial districts, to get public input on proposed redistricting map alternatives. Additional input was received by mail and email.

On June 15, 2011, based on the input received, and upon further consideration, the Board's Ad Hoc Redistricting Committee recommended that five of the maps, A\_1, C,

D, E and G, be considered by the full Board on June 28. On June 28, the full Board voted to recommend that Map E be adopted to adjust the boundaries of the supervisorial districts, with the first reading to be held on July 12.

Upon further review by the staff of the Registrar of Voters and the Community Development Agency, it was determined that Map E no longer included all of the City of Pleasanton within District 4, due to a recent annexation into the City of Pleasanton. As it was the Board's intent that all of the City of Pleasanton be included within the boundaries of District 4, staff has prepared for your consideration two modifications to Map E that would accomplish this.

Map E\_1 includes the newly-annexed area within District 4 (rather than District 1 under Map E). This property currently has no population, so the addition to District 4 would not change the population totals within each district. However, it is anticipated that future development of this property will result in a population increase of up to 1,000 people.

To partially offset the anticipated future increase of the population of District 4 due to the addition of the newly-annexed area, Map E\_2 was developed for your consideration. In addition to moving the newly-annexed area from District 1 to District 4, Map E\_2 moves the unincorporated Happy Valley area, immediately south of Pleasanton, from District 4 to District 1. This transfer would remove 285 people from District 4, based on the proposed district boundaries in both Maps E and E\_1, and add them to District 1.

The specific census blocks and population figures for Maps E\_1 and E\_2 are shown in Attachment A.

**FINANCING:**

The only cost related to this item, aside from staff time, is the cost of the redistricting software, which has already been budgeted for by the Clerk of the Board.

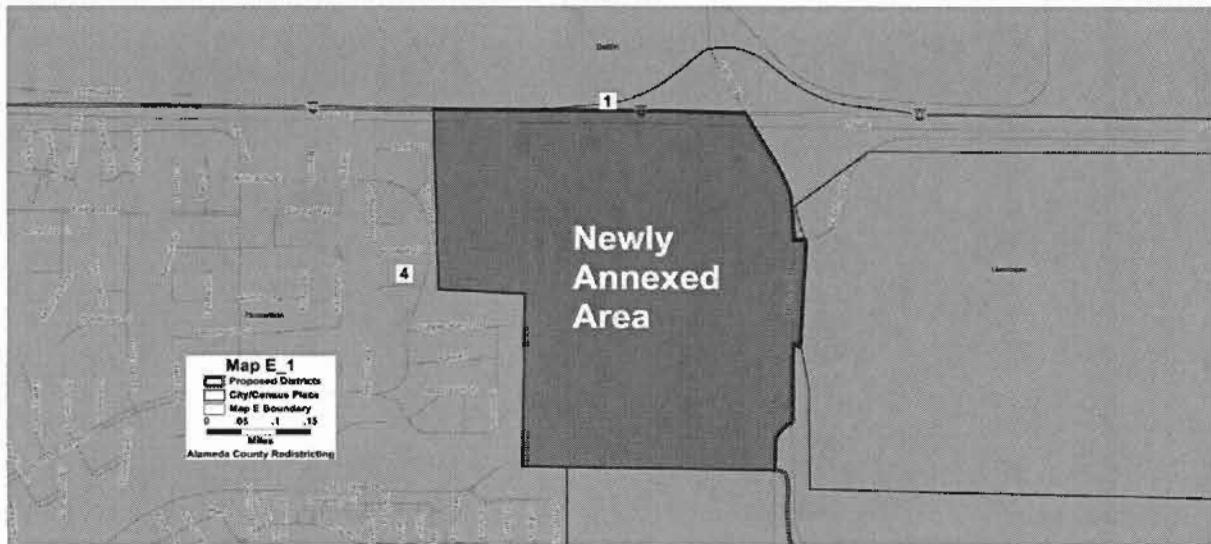

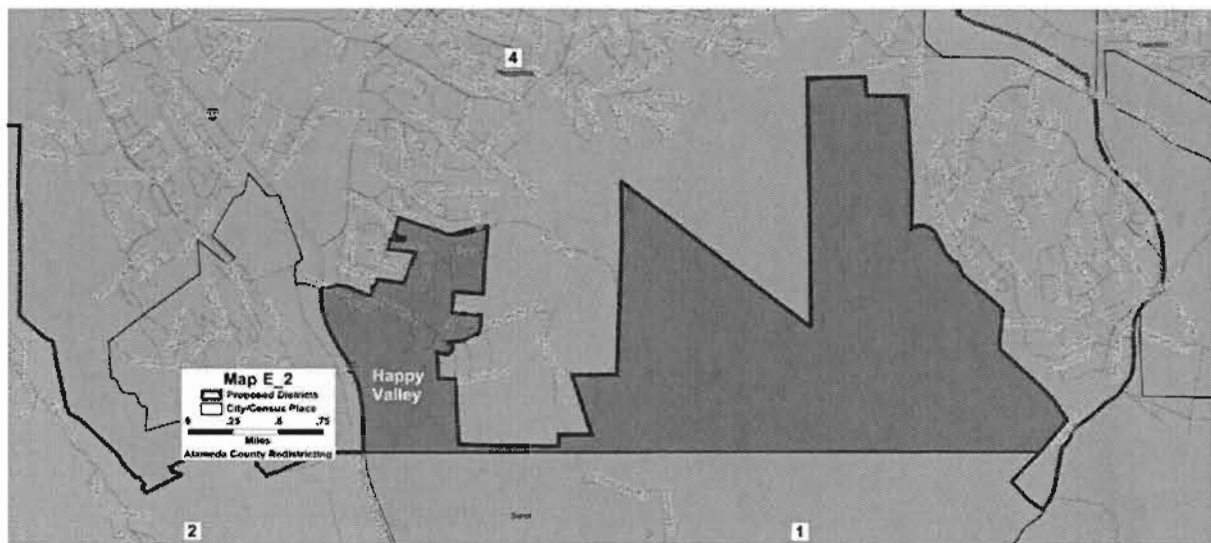

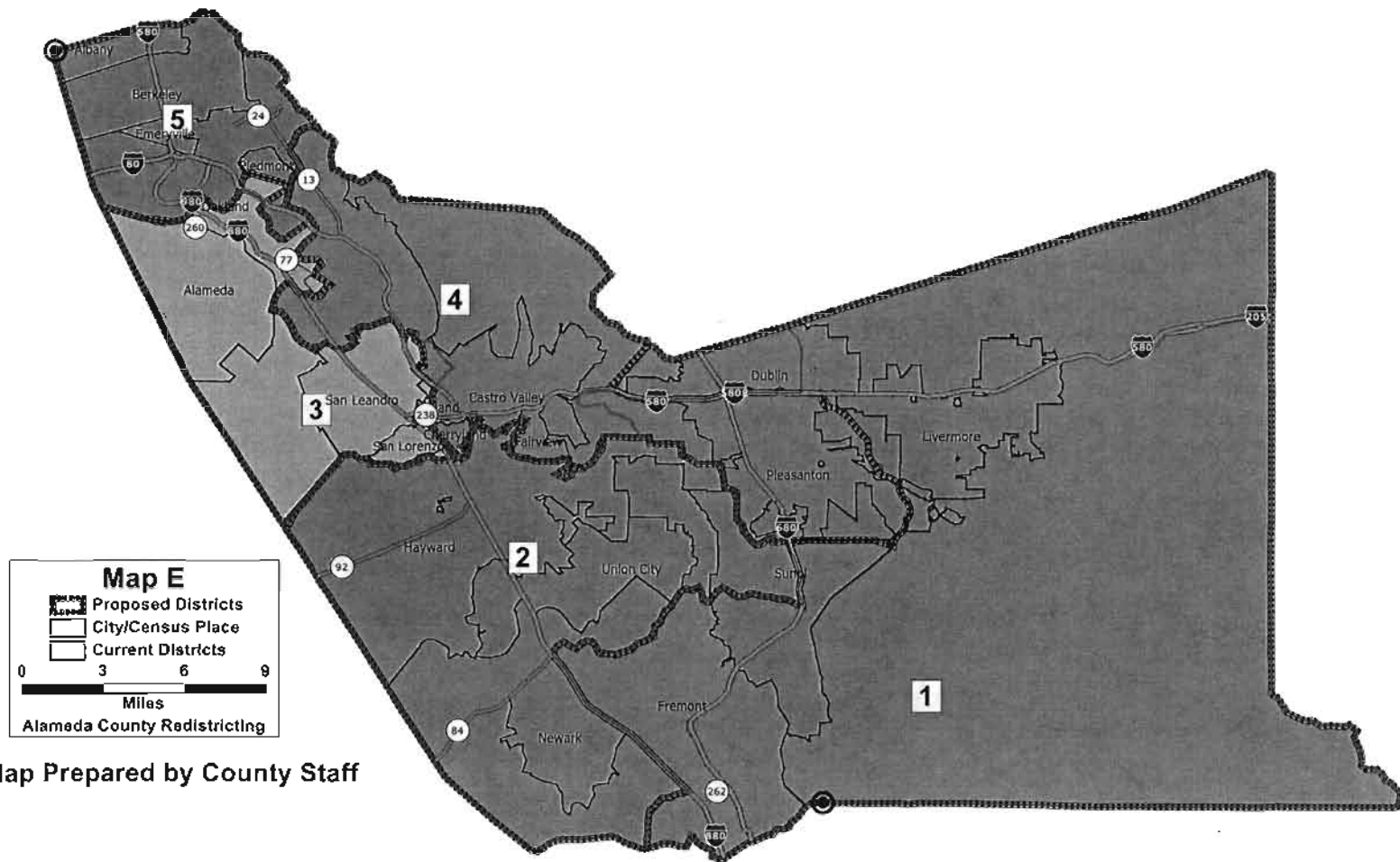
