SUBJECT: TIME EXTENSION AMENDMENT TO THE AGREEMENT BETWEEN THE ALAMEDA COUNTY PUBLIC WORKS AGENCY AND YEI ENGINEERS, INC. TO REVIEW AND EXAMINE EXISTING ELECTRICAL SYSTEMS AND PRODUCE A COMPLETE SET OF AS-BUILT DRAWINGS FOR THE PARK STREET DRAWBRIDGE SERVICES

RECOMMENDATION:

Approve and authorize the President of the Board of Supervisors to execute time extension amendment to contract No. <u>3813</u> with YEI Engineers, Inc. (Principal: Douglas Yung, P.E.; Location: Oakland, CA.), to review and examine existing electrical systems and produce a complete set of as-built drawings for the Park Street Drawbridge services, extending the contract ending date from August 31, 2009 to December 31, 2009 and no changes to the contract amount.

SUMMARY/DISCUSSION:

On April 28, 2009, your Board approved contract with YEI Engineers, Inc. to review and examine existing electrical systems and produce a complete set of as-built drawings for the Park Street Drawbridge services for the period April 28, 2009 through August 31, 2009 in the amount not to exceed \$58,110. YEI Engineers, Inc. started its project, simultaneously with an Earthquake Retrofit construction at Park Street Bridge. During the retrofit construction, an electrical malfunction caused a serious operational condition at Park Street Bridge. Special control boxes that contain sensitive calibrated switches, had to be recalibrated manually with reference to the electrical documentation that was to be turned over to YEI Engineers, Inc. The retrofit project has been completed and YEI Engineers, Inc. has since received all documentation and access needed to start the review work.

SELECTION CRITERIA AND PROCESS:

The consultant was selected in accordance with the PWA Consultant Services Handbook bidding procedures. On December 26, 2008, a Request for Proposal (RFP) was sent to ten (10) electrical engineering firms throughout Alameda and Contra Costa Counties. One of the ten was certified Small Local and Emerging Business (SLEB). Only YEI Engineers, Inc. responded. The PWA Selection Committee (SC) reviewed the RFP submission, and found YEI Engineers, Inc. highly qualified. YEI Engineers, Inc. has 34 years experience in providing electrical engineering services. It provided a clear understanding of the project and submitted a good scope of work and responses to our questions, therefore, the SC awarded the contract to YEI Engineers, Inc. SC was comprised of five (5) PWA representatives. With only one proposal, the vendor was interviewed, followed with a Q/A session, a site visit to the project location, and a review of the project documentation. YEI Engineers, Inc. is SLEB certified under certification number 02-89976, expires 10/31/2011.

FINANCING:

There is no cost to the General Fund. Funds for this project were fully encumbered in FY 2008/09 in County Bridges CSA B-1988-1, Org 270551, Account 610261, Professional & Specialized Services. No additional funds are required in FY2009/10.

WITNESSETH

Whereas, COUNTY and CONTRACTOR desire to extend the term of the Agreement to December 31, 2009, with no change in the contract amount of \$58,110;

NOW, THEREFORE, COUNTY and CONTRACTOR agree as follows:

- 1. The term of the Agreement shall be extended from August 31, 2009 to December 31, 2009, (the "Extension Term").
- During the Extension Term, CONTRACTOR shall continue providing services described in the Agreement and COUNTY shall pay CONTRACTOR for such services in an amount which shall not exceed \$58,110.
- 3. All provisions of the Agreement, except as modified by this Modification, shall remain in full force and effect.
