DISCUSSION/SUMMARY:

On May 22, 2015, the Auditor-Controller received an electronic transfer of \$2,524 from the US General Services Administration (USGSA) in reference to IN0186112, Trace/IA Number 02622385. The amount was deposited as miscellaneous revenue in Alameda County's General Services Agency (GSA) Building Maintenance Department.

On September 9, 2015, GSA received a letter from USGSA requesting refund of the abovereferenced amount. The USGSA indicated its payment in May 2015 was made in error.

GSA reviewed its accounts and found no matching debt or outstanding balance in this regard. As such, GSA concurs that the payment was an error and a refund is due.

FINANCING:

Funds are available in Account 610461, Fund 31030, Dept 410191, Budget Ref 2016 to meet the obligation for this refund. There is no impact in net County cost.
