Whereas, Judge Fudenna has served as Judge of the Superior Court of California, County of Alameda, since 1998; and

Whereas, Judge Fudenna, whose dedication, professionalism, and commitment has earned the loyalty and the highest regard of all those who have had the honor to work with him; through his conscientious public service has improved the present and future quality of life of Alameda County residents.
