Recommendation:

That your Board adopt a Salary Ordinance amendment establishing two new job classifications in the Auditor-Controller's Agency.

## Discussion/Findings:

The Auditor-Controller's Agency has requested the creation of two new job classifications; Job Code 0143NM, Auditor and Job Code 0144NM, Senior Auditor. Incumbents of the Auditor classification perform varied professional auditing, accounting and/or compliance assignments; record financial transactions and reports related information in compliance with Generally Accepted Accounting Principles (GAAP) and County policies and procedures; conducts audits in compliance with Generally Accepted Accounting Principles Standards (GAAPS); review accounting methods and practices of County departments, Special Districts and County contractors; and prepare financial, accounting and analytical reports.

Incumbents of the Senior Auditor classification also perform all of the aforementioned duties, but have a greater degree of independent responsibility and work more independently to perform the most complex auditing assignments, lead audit teams, or may be given lead responsibilities. Incumbents of the Auditor classification shall be eligible to promote after gaining experience and demonstrating proficiency which meet the minimum qualifications at the Senior Auditor level.

### Funding:

Funds are available in the 2012 and 2013 budget appropriation to pay the cost resulting from these actions.

#### SECTION I
