SUBJECT: APPROVE THE PROPOSED 2024 ANNUAL OPERATING BUDGET FOR THE ALAMEDA COUNTY AGRICULTURAL FAIR ASSOCIATION

RECOMMENDATION:

Approve the proposed 2024 Annual Operating Budget for the Alameda County Agricultural Fair Association as submitted by the Association and authorize the Board President to sign the required California Food and Agricultural budget forms.

DISCUSSION:

As in previous years, the Fair Association submits its Annual Operating Budget to the Board of Supervisors for review and approval prior to the required submission to the California Department of Food and Agriculture by the last day of each year.

The Alameda County Fairgrounds had a successful 2023 Fair with 445,000 attendees, up more than 7% from the prior year. A diverse entertainment lineup, horse racing, and a wide array of family focused activities, including a petting zoo, kids carnival, nightly movies on the lawn, and indulgent Fair food continue to attract diverse communities from throughout Alameda County and beyond.

The 2023 Year-End Operating Budget revenue is projected at \$30,346,952 and expenses are projected at \$27,546,952, resulting in net revenue of \$2,800,000. This represents a projected year-over-year decrease in net revenue of \$881,733 or 24%.

The proposed 2024 Operating Budget was approved by the Alameda County Agricultural Fair Association Board of Directors at its meeting on October 17, 2023. This budget projects increased revenue of \$574,390 and increased expenses of \$1,569,429, representing anticipated net revenue of \$1.8M.

Throughout 2024, staff from the County Administrator's Office and the Alameda County Fair Association will continue to meet on a quarterly basis to discuss operations that may cause significant adjustments to the 2024 operating budget presented to your Board for approval.






