County Administrator Approve a one month extension of Contract No. C-2003-129 with the Alameda County Fair Association (Principal: Anthony Varni; Location: Pleasanton) to continue to operate the Alameda County Fairgrounds from October 1, 2007 through November 1, 2007, under the existing contract terms and conditions
