## Summary Minutes

#### **PUBLIC COMMENT**

Ken Carbone stated that the majority of funds from the County for economic development are given to the Chamber of Commerce. The Chamber of Commerce contract is up for renewal and Mr. Carbone asked the Council is the Chamber of Commerce the appropriate place to spend County dollars.

I. Approval of Minutes - October 2012 minutes - continued to March 18, 2013.

### II. Redevelopment Projects Report

Eileen Dalton, Community Development Agency reported on the status of projects in the unincorporated area.

In February 2011, the Board of Supervisors approved a \$128 million dollar Public Improvement Agreement with the Redevelopment Agency to fund planned redevelopment projects. The projects were organized in two (2) tiers. Tier One projects were those projects that were vetted by the community and planned for implementation over the next five year period. Tier Two projects were identified projects that had not been fully vetted or were expected to be funded in the next five year period, after completion of Tier One projects.

After the dissolution of the Redevelopment Agency, in June 2012, as part of the annual budget adoption the Board of Supervisors agreed to provide funding for Tier One Projects, up to \$18 million dollars per year for up to five years.

#### **III. Law Enforcement Reports**

Officer Chris Sherry and Sergeant Mike Brush of the California Highway Patrol (CHP) presented a report for law enforcement activity in the Castro Valley area for the last quarter of 2012.

Speeding tickets – 1,769 Distracted driving - 134 Seatbelt citations – 214 Car seat violation – 39 Verbal warnings – 651 Injury accidents – 117 Property damage accidents – 250 Stranded motorists – 326

Sergeant Brett Scheuller presented a report for the Alameda County Sheriff's Office law enforcement Activities for the Castro Valley Area for the months of November and December of 2012 and January 2013

The Sheriff's Office participated in a bar crawl on November 21, 2012, which resulted in fifteen (15) arrests and nine (9) misdemeanors.

The Sheriff's Office reported that marijuana grow operations are on the rise. On November 30, 2012 the Sheriff's Office busted an illegal narcotics operation in a private residence that was guarded by an alligator.

On December 20, 2012 the Sheriff's Office participated in a minor decoy operation for tobacco sales which resulted in three (3) violations.

The Sheriff's Office participated in the 21 DUI Campaign for the holiday season, which resulted in 361 DUI arrests.
