I. Alameda County Sheriff's Office Strategic Plan Attachment

Don Buchanan, Division Commander, Alameda County Sheriff's Office, presented a PowerPoint presentation on the Sheriff's Office Strategic Plan.

The Sheriff's Office Strategic Plan is a process that began with an assessment of current organizational issues. Staff examined pending trends, projected future scenarios, assessed the ability to cope with present and future challenges and prioritized the issues. An action plan has been developed which addresses the prioritized issues and establishes a defined path to achieve the Sheriff's Office desired vision.

The planning period determined based upon the group's discussion and identification of the primary issues which require our focus and attention, that a planning period of three years was most appropriate. This is a 24-month review of the three year plan.

A total of seventy-eight projects have been established as a result of the Strategic Plan, each with action items to evaluate the process and measure outcomes.

The current fee charged by the Coroner's Bureau for Body Removal is \$254 and the proposed new fee is \$333. The current fee charged for a private autopsy by the Coroner's Bureau is \$2,000 and the proposed new fee is \$4,000.

PUBLIC COMMENT

Brandon Sturdivant, Oakland Community Organization, spoke about challenges in the criminal justice system. Last year community based organizations (CBO's) received fifty percent (50%) of the funding for AB 109 realignment programs. There should be a clear strategy for the AB 109 procurement process, as the RFP process has been slow. He would like to see the 50% funding to CBO's; a serious process for procurement, community input, easier collaborative process and pre-trial release and probation terms.

Darris Young, Ella Baker Center, stated that the County needs to do a better job of allocating funding for the AB 109 programs, expand services and implement pre-trial release programs.

Charles Eddy, Urban Strategies Council, is very concerned about the Board reaffirming their commitment to funding CBO's at 50% of the AB 109 realignment funding; the money is being procured slowly; more efficient procurement process; acknowledge that we should have a pre-trial release program;
