I. **AB 109 Public Safety Realignment Year 5 (July 1, 2015-June 30, 2016) Status Update** [Attachment](#)

Neola Crosby, Re-Entry Coordinator, Probation Department and Wendy Still, Chief Probation Officer, presented a PowerPoint presentation to update the Committee on the AB 109 Year 5 Public Safety Realignment.

The presentation included information on the realignment funding allocations, programs, outcomes and results-based accountability (RBA) and status updates.

For fiscal year 2015/2016 the Board allocated 50% of the base allocation for realignment funding to community based organizations (CBO's) to fund realignment programs. An additional \$3 million dollars was included for increased services for employment. Allocations to CBO's totaled \$24.3 million. A total of \$24.3 million in realignment funding was allocated to the Sheriff's Office (18.5 million), Probation Department (\$3.2 million), District Attorney (\$1.3 million) and Public Defender (\$1.3 million) to fund realignment programs.

II. Leaders in Community Alternatives (LCA) Electronic Monitoring Program

Linda Connelly, President/CEO, Leaders in Community, presented a PowerPoint presentation on the Electronic Monitoring Program.

LCA Provides Electronic Monitoring Services at no cost to Alameda County and is participant funded with sliding scale. LCA has a Memorandum of Understanding (MOU) with the Probation Department.

Benefits of electronic monitoring include:

- Increase Accountability
- Provide Court with Options
- Reduce Incarceration Costs
- Improve Public Safety
- Allow defendants to remain in the community working, paying taxes, restitution, fines, maintain household and support families
- Practice prosocial behavior in their home

The types of electronic monitoring include: 1) GPS tracking which provides 24 hour a day tracking; 2) Home detention/curfew monitoring; 3) continuous alcohol monitoring (CAM) which monitors alcohol use and testing every 30 minutes.

2016 Title 15 County Jail Health Inspections

Dr. Muntu Davis, Public Health Director & County Health Officer, Health Care Services Agency, presented a PowerPoint presentation on the 2016 Title 15 County Jail Health Inspections for Santa Rita Jail and Glenn Dyer Jail.

Health and Safety Code §101045 states that the County Health Officer shall investigate health and sanitary conditions in every county jail and every other public detention facility at least annually.

Recommendations from the inspections include

- Ensure special diet orders are entered into the Food Service Department system and regularly reviewed; Establish automatic review for those incarcerated longer than one year;
- Increase the number of healthful food and beverages in vending machines
- Expand gender options on intake form to include transgender options such as male to female and female to male
- Update the facility's dental care policies and procedures to reflect the guidelines from the Department of Correctional Health Care Services' Inmate Dental Service Plan

Ronald Torres, Supervising Registered Health Specialist, Environmental Health Department, Health Care Services Agency presented a PowerPoint presentation on the Department's Annual Inspection of Santa Rita Jail.

The jail was originally constructed in 1947 and "re-built" and expanded in 1989 and it is the 3rd largest jail facility in California and 5th largest jail facility in the United States. The potential capacity can house and feed over 4000 inmates, current population estimates of approx. 2100 inmates.

The Environmental Health inspection determined that there were no major violations with respect to food preparation, handling or hygiene were observed. Hot and cold food temperatures and the temperatures of all refrigeration units were documented, logged and maintained for the all refrigeration units in the Main Kitchen, Staff Dining Kitchen and each of the inmate housing units

Inmate Housing Units determined with random cell inspections that there is normal "wear and tear" with regard to inmate mattresses.

Blocked/partially blocked ventilation ports were consistently observed in the majority of inspected cells. Each cell receives a thorough "overhaul" during inmate turnover, at which time the ventilation ports are unblocked.

Evidence of vermin activity observed in the upstairs dry storage areas, mainly at the floor-wall junctures, on canned food storage shelving; two (2) "electrical rooms" with restricted access. Corrective action included a clean-up of the area and all access "holes" leading to these rooms sealed off. No 'new' access holes were observed during the inspection.
