# **MINUTES**

Community Member inquired about graffiti on Interstate 680 freeway entrances. Chris Miley, Supervisor Valle's office, answered that he will contact Alameda County Public Works Agency and Caltrans to determine who can clean it up.

Community Member voiced his concerns about the amount of advertisement billboards in Sunol.

Alameda County Sheriff's Office – Deputy Jon Hamm informed Mobile Citizens application is a great tool to use to notify Alameda County Public Works Agency about graffiti, potholes, trash, etc. Users are able to send a picture with the location through the application.

CDA is attempting to separate the amount of regulations between the rural residential zones and agricultural zones of Sunol and other areas of unincorporated Alameda County. CDA is looking to allow a certain amount of soil importing in rural residential areas through tiering systems, depending on the property size.

Member Beemiller provided a statement promoting top-soil agricultural enhancements.
