**Alameda County Sheriff's Office** – Deputy Inns and Deputy Younan stated there were no major incidents to report.

**Alameda County Fire Department** – Bonnie Terra reported 27 calls for service since the last Council meeting. No fires were reported.

**Sunol Septic Working Group** – The workgroup last met on 5/8/18. A discussion occurred about how the workgroup would operate its meetings. In the future, Agendas will be posted 2-3 weeks in advance, members will stay on topic and the answers to questions will be posted on the workgroup's webpage. At its June meeting, the feasibility study and homeowner questionnaires will be discussed. At the workgroups July meeting, how to maintain a septic tank will be discussed. There will be no meeting August. In September the Planning Department will be presenting.

5. **UPDATE ON SUNOL QUIET ZONE IMPLEMENTATION – ALTAMONT CORRIDOR EXPRESS – Informational Item**

Bryan Pennino from Pennino Management Group stated that all improvements have been installed and are now complete. The official Notice of Establishment will go out 5/18/18. The proposed commencement date for the Quiet Zone is 6/30/18. An asphalt median was installed and will be maintained by the Alameda County Public Works Agency. In response to concerns, a break in the median was requested as well as quad gates. Bryan was invited to come back to the Sunol Citizens' Advisory Council at its 8/15/18 meeting to provide a progress report.
