I. FEDERAL LEGISLATION (Chris Strobel)

Legislative Update

The House and Senate each passed a supplemental appropriations bill that includes language for troop with-drawal. The Senate will be back in session next week after the Easter/Spring break and the House will be out for two (2) weeks.

The House and Senate each passed a FY 2008 Budget Resolution. Senator Feinstein offered an amendment to increase the budget allocation for the State Criminal Alien Assistance Program (SCAAP).

II. STATE LEGISLATION (Lynn Suter/Steve Wallauch)

Legislative Update

The California Legislature is out for Spring Break and they will return on Monday April 9, 2007.

The Governor signed SB40, the Sentencing Reform bill, which provides judges greater discretion in sentencing determinations.

The Secretary of State, Debra Bowen released recommendations last week for reviewing electronic voting machines. The public comment period was only for one week.

The Governor's has announced his plans expanding children's health coverage. Alameda County would be awarded \$24 million over the next three (3) years. There is \$540 million statewide for expanded coverate.
