# **SUMMARY ACTION MINUTES**

Supervisor Scott Haggerty called the meeting to order.

I. FEDERAL LEGISLATION (Jim Copeland/Emily Bacque)

#### Legislative Update

The House passed the Water Resources Development Act, which is a bill that includes money for Army Corps flood control projects. The House also passed a bill last week to give the District of Columbia full voting member of the House. The bill would increase the voting membership of the House from 435 to 437 members. It would accommodate a D.C. representative and one from another state, likely Probably Utah.

The Senate will take up similar legislation. In the Senate, Republicans blocked a bill that would permit the secretary of Health and Human Services to negotiate for lower Medicare prescriptions and drug prices.

This week the focus will shift to the supplemental appropriations bill to fund the war in Iraq. Conferees are scheduled to meet this afternoon. The President has said he will veto any bill that contains troop withdrawal language.
