The Long Road to Equity in Public Contracting

In 2003, Alameda County retained Mason Tillman and Associates (MTA) of Oakland to conduct an Availability Study. The purpose of the Study was to review the County's procurement activities to ensure that contracting opportunities are accessible to the entire local business community. The study reviewed the County's outreach and contracting practices in the areas of Construction, Architecture and Engineering, Goods and Other Services, and Professional Services by examining contractors that received payment from the County from July 1, 2000 through June 30, 2003. Some of the initial recommendations provided by Mason Tillman include the development of a Countywide Compliance Office and providing numerous support services for smaller construction companies.

Foster Parent Appreciation

Alameda County is one of the most ethnically and economically diverse communities in the state and possibly the country. According to the current census data, the population in the County is estimated to be about 1.4 million residents. About 19% of the population is children under the age of 14 and about 15% or 40,654 of children aged 6-14 live in poverty. Another staggering number is the number of children who are in Alameda County's Foster Care system. It is estimated that there are about 3,200 children in the foster care system. About 60% of the children in care are African American. One of the major factors contributing to youth coming into the foster care system is poverty.

Our State must make sure we have teachers to ensure the success of our 6.3 million students. My staff attended the California Budget Project in Sacramento, on March 16, 2006, and the question was asked: "Are More Storm Clouds Looming on the Horizon?" Margaret Gatson, the Executive Director of the Center for the Future of Teaching and Learning (CFTL) raised the issue. Gatson later asked, "What are we going to do for those in the classrooms?"
