PLN2019-00226, CONDITIONAL USE PERMIT (CUP), MULQUEENEY RANCH WIND LLC (SUBSIDIARY OF BROOKFIELD RENEWABLE ENERGY PARTNERS) – Application to allow repowering of a former 70-Megawatt (MW) wind energy facility containing an estimated 518 existing or previously existing turbine sites, with a maximum production capacity of 80.0 MW, using up to 36 new turbine sites and turbines rated between 2.2 and 4.2 MW per turbine, on twenty nine (29) parcels located north and south of Patterson Pass Road between approximately one-third and four miles west of Midway Road, and between one and five miles south of Interstate 580. The project site comprises 29 parcels extending over approximately 4,600 acres, including the following Assessor Parcel Numbers (APNs):

The proposed Project (application) is broadly consistent with the Repowering Program that was the subject of a Program Environmental Impact Report (PEIR) for Repowering the Altamont Pass Wind Resource Area (APWRA) certified by the East County Board of Zoning Adjustments on November 12, 2014, and is therefore reviewed as a tiered project with a Subsequent Environmental Impact Report (SEIR) pursuant to Section 15162 of the California Environmental Quality Act (CEQA) Guidelines.

A Notice of Availability of the Draft SEIR including notice of this public hearing was provided to area residents, affected agencies and interested parties on November 6, 2020. A virtual public hearing was held by the Alameda County Planning Department on December 8, 2020. The comment period was extended from a 45-day period to more than 60 days, ending on January 8, 2021.
