Only those issues which are brought up at the public hearing described in this notice, or in written correspondence delivered to the LAFCo Commissioners at or prior to the hearing, may be raised in any legal challenge to the actions taken by the Commission.

<u>DISCLOSURE OF BUSINESS OR CAMPAIGN CONTRIBUTIONS</u> <u>TO COMMISSIONERS</u>

Government Code Section 84308 requires that a Commissioner (regular or alternate) disqualify herself or himself and not participate in a proceeding involving an "entitlement for use" application if, within the last twelve months, the Commissioner has received <u>\$250</u> or more in business or campaign contributions from an applicant, an agent of an applicant, or any financially interested person who actively supports or opposes a decision on the matter. A LAFCo decision approving a proposal (e.g., for an annexation) will often be an "entitlement for use" within the meaning of Section 84308. Sphere of Influence determinations are exempt under Government Code Section 84308.

If you are an applicant or an agent of an applicant on such a matter to be heard by the Commission and if you have made business or campaign contributions totaling \$250 or more to any Commissioner in the past twelve months, Section 84308(d) requires that you disclose that fact for the official record of the proceeding. The disclosure of any such contribution (including the amount of the contribution and the name of the recipient Commissioner) must be made either: 1) In writing and delivered to the Secretary of the Commission prior to the hearing on the matter, or 2) By oral declaration made at the time the hearing on the matter is opened. Contribution disclosure forms are available at the meeting for anyone who prefers to disclose contributions in writing.

City of Pleasanton Reorganization Vineyard Avenue Annexation/Detachment No. 148 The Commission will consider an application filed by City of Pleasanton to annex 8.40 acres to and detach 0.182 from the City of Pleasanton the purpose of realigning Vineyard Avenue along the Arroyo del Valle; annex 2.79 acres to the City of Pleasanton in order to merge it with a lot located within city limits and develop the subject property consistent with the Vineyard Specific Plan; and detach from the City of Pleasanton 6.73 acres which will not be developed as part of the Vineyard Specific Plan and which will be returned to unincorporated status. The proposal also includes concurrent detachment and annexation of the same territory from the Alameda County Fire Department and the Alameda County Library District.

4. City of Pleasanton Reorganization – Dutra Annexation No. 151 – The Commission will consider an application filed by City of Pleasanton to annex 10.05 acres to the City of Pleasanton to facilitate development of the property consistent with the Happy Valley Specific Plan. The same territory will be detached from the Alameda County Fire Department and Alameda County Library District.
