

**NOTICE OF PUBLIC HEARING  
ALAMEDA LOCAL AGENCY FORMATION COMMISSION**

**NOTICE IS HEREBY GIVEN** that the Alameda Local Agency Formation Commission will hold a regular meeting on **Thursday, November 9, 2006 at 4:30 p.m.** at the Dublin San Ramon Services District Board Room at 7051 Dublin Boulevard, Dublin, California.

At the hearing, the Commission will discuss the following items:

- **Union Sanitary District Annexation U 285 and ACWD Annexation 103** –Annexation of one parcel (APN: 087-0034-002-07) totaling 6± acres to Union Sanitary District and Alameda County Water District to provide sanitary sewer and water services to proposed single family detached homes located southwesterly from the intersection of Mission Boulevard and 7<sup>th</sup> Street and at the end of Florence Street in the City of Union City. The area is within the spheres of influence of both districts.
- **Las Positas Road Reorganization No. 5 (also referred to as Hilliker) Annexation to the City of Livermore and Detachment from the Alameda County Library District and the Alameda County Fire Department** – Proposal from the City of Livermore to annex 45± acres to the City of Livermore and detach the same territory from the Alameda County Library District (ACLD) and Alameda County Fire Department (ACFD), with corresponding amendments to the ACLD and the ACFD Spheres of Influence, for the purpose of eliminating an unincorporated island within the City limits, and to maintain and support the existing rural character of the subject site. The property consists of 14 parcels (APNs 099-0015-031-00, 099-0015-030-00, 099-0015-024-00, 099-0015-040-00, 099-0015-025-04, 099-0015-023-04, 099-0015-026-06, 099-0015-039-00, 099-0015-022-02, 099-0015-022-03, 099-0015-020-06, 099-0015-020-07, 099-0015-020-04, 099-0015-026-05) and is located adjacent to and south of Las Positas Road, east of North Livermore Ave.
- **Sphere of Influence (SOI) Updates for the cities of Berkeley and Oakland** – In July and September, the Commission approved SOI updates for 28 agencies in conjunction with the Municipal Services Review - Vol. III – Community Services. SOI updates were deferred on the two agencies listed above.

At the meeting, the Commission will consider all oral and written testimony of any interested persons or affected agencies. Only those issues which are brought up at the public hearing described in this notice or in written correspondence delivered to the LAFCo at or prior to the hearing may be raised in any legal challenge to the actions taken by the Commission with respect to an application.
