NOMINATION PERIOD FOR NOVEMBER 3, 2020 GENERAL ELECTION

The nomination period for the November 3, 2020 General Election began on **Monday, July 13, 2020 and will close at 5:00 p.m. on Friday, August 7, 2020**. In the event that an incumbent officer fails to file for re-election, the nomination period for that office is extended until Wednesday, August 12, 2020, for any eligible candidate except for the incumbent.
