ALAMEDA COUNTY REGISTRAR OF VOTERS  
ANNOUNCES WEEKEND VOTING HOURS AND EARLY VOTE OPTIONS  
FOR THE NOVEMBER 3, 2020 GENERAL ELECTION

In response to the COVID-19 health emergencies, the Registrar of Voters is following the safety guidelines set forth by the California Secretary of State and the Center for Disease Control by practicing physical distancing and wearing face coverings. As a voter, you can minimize the risk of COVID-19 transmission at polling locations by using personal prevention practices. This includes wearing a mask and maintaining at least six feet of distance from people who don't live with you. Voters can also vote the ballot sent to them and drop it off early at the Official Ballot Drop Boxes, USPS mailbox, or at an Accessible Voting Location. Vote Safely and Stay Healthy!

**In-Person Voting**

The Alameda County Registrar of Voters will be open for weekend voting and early voting to allow voters to cast their vote in-person at the Registrar of Voters' Office *or* at any one of the Accessible Voting Locations within the County.

The Registrar of Voters' Office is located inside the René C. Davidson Court House at 1225 Fallon Street, Room G-1, Oakland, CA. Voters wishing to cast ballots during weekend hours will be able to access the Registrar of Voters' Office by using the 12th Street entrance of the Court House.
