NOMINATION PERIOD OPENS FOR JUNE 5, 2012 PRESIDENTIAL PRIMARY ELECTION

The nomination period for the June 5, 2012 Presidential Primary Election opens on Monday, February 13, 2012* and ends on Friday, March 9, 2012 at 5:00 p.m. In the event that an incumbent fails to file for re-election, the nomination period for that office is extended until Wednesday, March 14, 2012 for any candidate other than the incumbent.

NOTE: Asterisked date indicates that the date falls on a (County observed) holiday - this period will open on the next business day.

Nomination documents are available at the Alameda County Registrar of Voters Office, 1225 Fallon St., Room G-1, in Oakland. Candidates for municipal offices should contact the respective City Clerk for information on obtaining nomination documents.
