IMPORTANT PERIODS FOR CANDIDATES AND LIST OF JURISDICTIONS FOR JUNE 3, 2014 STATEWIDE DIRECT PRIMARY ELECTION

The Statewide Direct Primary Election will be held on Tuesday, June 3, 2014. Below is a list of important periods for candidates who plan to run for office as well as a list of jurisdictions to be consolidated with this election.

IMPORTANT PERIODS

Signatures-in-Lieu Period: December 27, 2013 – February 20, 2014

Period in which all voter-nominated candidates may obtain forms from county election officials for circulating petitions to secure signatures in lieu of all or part of the filing fee. Signatures may also be applied to the nomination signature requirements for office.

Declaration of Intention Period (Judicial candidates only): January 27, 2014 – February 5, 2014

Declaration of Intention is only required for the Office of Superior Court Judge – candidates are required to file a Declaration of Intention in order to become a qualified candidate for Superior Court Judge. The non-refundable filing fee is due at the time of filing the Declaration of Intention form.

Nomination Period: February 10, 2014 – March 7, 2014

Period in which all candidates must file nomination documents and their declaration of candidacy for office.
