 - 1. Are MDT's being conducted? Do the aftercare probation officer on campus continue to be the youth's probation officer in the community?
 - a. A: Yes, the youth retains the same probation officer in the community. Yes, the MDT meeting is conducted while the youth is in





juvenile hall and when they arrive and throughout the youth's time at the Ranch.

- 2. The Missouri Model is about small home-like settings correct? Have you been able to create those settings in your models?
 - a. A: We have created small college-like settings that are self-contained; with 10 youth per dorm. Families and community providers are heavily involved
 - b. A: We have created small cottage-like settings which house a max of 8 youth. The model calls for keeping youth together at all times and we have been successful in that.
- 3. Are youth at your facilities committed for 707(b) offenses?
 - a. A: Yes, 80% of the youth are 707(b) offenses, but not 707(b) offenses that would be direct filed, transferred, or go to DJJ.
- 4. What is your staff turnover rate?
 - a. A: Our turnover rate at the Ranch is low, our turnover rate at Juvenile Hall is high. The staff are paid as much as probation officers; they shift differential and overtime; we are able to keep good staff.
- 5. What do you recommend for the staffing ratio?
 - a. A: 1:3; the more adults on-site the better.
- 6. Are families allowed to visit?
 - a. A: Yes, we have traditional visits every Sunday and family therapy visits that a set up through DMH.
- 7. How are you able to support staff from burnout?
 - a. A: We have focus groups for staff that is led by DMH.
