Discussion: Chairman Smith asked County Council Scott if he would be able to guide members of the CAB with questions, concerns members may have, and if he would be available to assist the CAB with composing a letter to address the concerns with the county. Scott said he would help as needed, be it with a letter or scheduling meetings. Lou made a point that the meetings Scott was referring to are held in during the day, and most are not aware. He suggested sending a CAB member to the meetings for representation. And voted to see who agreed on composing a letter.

- Relationship building exercises

Chairman Smith will resend the email with the information on date, time, and location of the CAB retreat. Not all members are available on December 18th, a hard date will be discussed offline. Scott advised that 72-hour notice was not required, as it is a special meeting.

8. Ex-officio voting member of the CCPEC (re-visited) – (Discussion and Action)

Discussion: Chairman gave facts concerning the importance of having impacted individuals as part of the voting body of the CCPEC. He advised the community that not allowing impacted individuals to be heard through the CCPEC vote, although through Prop 47, people on parole and probation are now able to vote. The lack of our vote stifles not only our voices but hinders us from forward movement in life. CAB member Tanasha, spoke to how she realized that one vote matters, and the impact of just one vote. Chairman Smith will follow-up with County Counsel. Ray asked for clarification- are we asking to vote with CCPEC or are we asking to change legislation. He further stated that it was not illegal for us to vote. Scott will assist as long as the County of Alameda gives permission.
