2. **Review and Approval of the Fiscal Year 2022/2023 Community Corrections Partnership Annual Report – Janene Grigsby**
 - a. The Annual Report is a way to tell the state what is being done locally to implement the public safety realignment plan: what has been done over the past year and what the plan is for next year moving forward
 - b. The timeline:
 - i. August 16, 2022 – All submissions were due
 - ii. October 5 – The CCP were to vote on approving the report (no vote was taken due to lack of quorum)
 - iii. October 26 – Today’s joint meeting of the CCP and CCPEC to vote on approving the report
 - iv. November 22 – Submit the report to the Board of Supervisors (BOS) for approval
 - v. December 6 – Submit the report to the Board of State and Community Corrections (BSCC); the report is due to the state by December 15
 - c. The report is broken down into six sections:
 - i. Overview – An overview of Alameda County CCP and CCPEC
 - ii. Fiscal Investments – A review of the fiscal investments over the last year
 - iii. Demographics – A breakdown of Probation demographics

- iv. Recidivism – The recidivism rates in Alameda County
 - v. Partner Agencies – Each of our partner agencies
 - vi. Subcommittees – A report out from each of the CCP subcommittees on what has happened in the past year and what their plans are for the year moving forward

- i. Changes to the District Attorney’s section
 - ii. Small grammatical changes
