1. **Call to Order and Introductions** – The meeting was called to order at 2:00 PM
2. **Public Comment on Any Item Listed Below for "Discussion Only"**
3. **Funding Recommendations: [Additional Allocation for the Current Employment Vendor Pool Contract](#) – Gina Temporal**

This recommendation is for \$2,225,000 to continue funding employment through the end of the contract (current contract term is 4-1-2020 to 3-31-2023); \$1,000,000 was set aside in FY18/19 for increase subsidized hours and this recommendation includes allocating those funds, leaving a fiscal impact of \$1,225,000 for FY22/23

Goal of the Employment Program: (1) Help define career goals for the participant; (2) The provider assists the clients to position themselves with employers; (3) Help clients develop technological skills; and (4) Assist clients in building professional networks

a. Building Opportunities for Self Sufficiency (BOSS)

- i. Boss shared some of Alameda County’s statistics for poverty, the affect COVID has had on their employment outcomes, and the trauma that clients carry; a client shared how the program has positively impacted his life

b. La Familia

- i. La Familia staff shared about the impact COVID has had on their program, the program’s success, and testimony from clients

c. Success Centers

- i. Success Centers shared what their program encompasses, some of their employment partners, future plans, and client testimony

If this recommendation is not approved, the program would stop June 3, 2022, impacting 575 active clients and 76 active transitional work program participants

Discussion:

- A suggestion was made to possibly form a small workgroup around data collection
- Clients and providers spoke about their experience with the program, and community members voiced support for it
- *A motion was made to approve \$2,225,000 for the continuation of the employment contract to 3-31-2023; motion was seconded; **motion passes unanimously***
