<p>PROCESS AND EVALUATION</p>	<p>Proposed charge: Define and develop the plan for, implementation, and evaluation of, Realignment activities in Alameda County.</p>	
	<p>a. Articulate CCP’s goals for Realignment in Alameda County with defined measures of success</p> <p>Some goals are already articulated, some are being changed, after we identify them what would be next, understanding the climate?</p> <p><i>(Is this the role of the CCP EC? Some of this is articulated in the Road to Re-Entry If we took this on, it would require the input from all the CCP EC workgroups.)</i></p> <p>Jenane suggested we could see if the CCP EC is funding what the CCP states as their goals.</p> <ul style="list-style-type: none"> The CCP workgroups are in entirely different places – collecting what they want may be difficult (start with what we have.) <p>b. Identify key indicators and measures of the agreed upon outcomes and benchmarks for successful implementation of Realignment.</p> <p><i>(This requires collaboration from other workgroups and an agreement from the Data & Information Management Workgroup)</i></p>	<p>Common understanding of goals and intentions and how measured</p> <ul style="list-style-type: none"> Successfully implement a data driven planning and decision making approach to Realignment implementation

<p>d. Develop clear planning processes (and annual schedule)</p> <p>(Unclear about what this means – we are not in a position dictate what other CCP Committees and EC Workgroups do.)</p>	<p>Work takes place in efficient, effective, and transparent ways</p>
<p>e. Develop, facilitate and implement a comprehensive and independent evaluation plan of Realignment efforts in Alameda County</p> <p>(The Workgroup has successfully assisted in crafting the RFP for ongoing evaluation of the government and the CBO expenditures.) Probation is now required follow a template when submitting the yearly update to the State.</p>	<p>Ensure that the efforts and effectiveness of Realignment are evaluated.</p>
<p>f. Articulate the structure by which Realignment and reentry efforts in Alameda County will be coordinated.</p> <p><i>(Potentially we could articulate a structure – I am a bit unclear about what that means – re-entry efforts are covered by the CCP. We should develop a process for coordination with the CCP Committees)</i></p> <p>Can we develop a process for committee coordination. A rotation of updates, the committee chairs meet, the meetings are recorded.</p>	<p>Coordinate reentry and Realignment activities in Alameda County</p>
