Community Corrections Partnership (CCP) & Adult Reentry Strategic Plan Overview for CCP Subcommittees

1. Community Correction Partnership (CCP):

- Established under SB678 in 2009 for the purpose of implementing the evidenced-based programming with overarching goals to alleviate state prison overcrowding and save state General Fund monies.
- b. 11-member body comprised of: Chief Probation Officer (CCP Chair), Presiding Judge of Superior Court (or Designee), Sheriff (or Designee), Director of Health Care Services Agency (or Designee), Director of Social Services Agency (or Designee), Superintendent of County Office of Education (or Designee), District Attorney (or Designee), Chief of Police, Public Defender (or Designee), Representative from a Community-Based Organization, Individual Representing the Interest of Victims. (CCP Membership as of December 2019)

2. Community Correction Partnership Executive Committee (CCPEC):

- a. Established under AB109 (2011) under the Public Safety Realignment Act that diverts defendants convicted of less serious felonies to serve their time in local county jail rather than state prison.
- b. 7-member body comprised of: Chief Probation Officer (CCP Chair), Presiding Judge of Superior Court (or Designee), Sheriff (or Designee), Director of Health Care Services Agency (or Designee), District Attorney (or Designee), Chief of Police, Public Defender (or Designee).

3. Alameda County Adult Reentry Strategic Plan – Road to Reentry:

- a. Initial Plan was adopted by the Alameda County Board of Supervisors (BOS) in 2014
- b. 2019 Update was adopted by the BOS in 2020
- c. The Plan outlines vision statements (population statement and system statement), guiding principles, and overarching themes
 - *i.* **Theme 1** Reduce Recidivism (Goal: To promote community safety and improve the quality of lives of all people in the community by reducing recidivism defined as: "rearrest, re-conviction, or return to incarceration/custody for people with conviction histories, with or without a new sentence within three years.)
 - *ii.* Theme 2 High Quality, Comprehensive Wrap Around Services Beginning at First Point of Contact with the Criminal Justice System, with a Reintegration and Reunification Focus that Leads to Pro-social Outcomes. (*Goal: Reentry planning and response begins at the earliest possible point of contact with the criminal justice system and continues until "successful" reintegration, as defined by an individualized plan and the acquisition of positive services and social-based outcomes that are high-quality, peer involved, and comprehensive).*
 - *iii.* **Theme 3** Develop a Network of Well-Coordinated Systems of Services (Goal: Develop an effective, culturally responsive, well-coordinated system of services that promotes

evidenced-based practices with and for those impacted by reentry, including individuals, their families, victims, and the community.)

- iv. Theme 4 Accountability, Transparency, Fiscal, and Performance Outcomes (Goal: Ensure transparency and accountability through outcome-based evaluations based on evidentiary practices and a supporting information system that has the ability to track individual services, provider and system outcomes, and collect appropriate data/statistics.
- d. 2019 Alameda County Reentry Population
 - i. All people living in Alameda County who have had contact with the criminal justice system.
 - ii. Total Alameda County Reentry Population: 528,000 (Comprised of adults supervised by Probation, California Department of Corrections and Rehabilitation (CDCR), the Court, Federal, and Post Sentence estimate)

4. CCP Subcommittees:

- a. Civic/Community Engagement (Co-Chairs: CAB Chair/CAB Co Chair)
- b. Education (Chair: Superintendent of County Office of Education or Designee)
- c. Family Reunification/Stability (Co-Chairs: Director of Child Support Services & Director of Fatherhood Corps)
- d. Housing (Chair: Director of CDA or Designee)
- e. Mental Health (Chair: Director of HCSA or Designee)
- f. Physical Health (Chair: Director of HCSA or Designee)
- g. Substance Use Disorder (Chair: Director of HCSA or Designee)
- h. Workforce Development/Employment (Director of Social Services or Designee)

Note: Each CCP Subcommittee has various strategies to be implemented to achieve the above referenced goals. As well, each Subcommittee has respective performance measures to assess outcomes.

5. CCPEC Workgroups:

- a. Fiscal & Procurement (Chaired by CPO & DA)
- b. Programs & Services (Chaired by Probation)
- c. Process & Evaluation (Chaired by PD)
- d. Data & Information Management (Chaired by DA)
- e. Community Advisory Board (CAB) is 15-member board appointed by the BOS with three (3) members representing each supervisorial district. CAB requires that minimally one-third of its membership be comprised of formerly incarcerated persons to ensure a "community voice" on matters related to Realignment and Reentry.) (Chair & Vice Chair voted by CAB membership)
