Grants Update – Monica Uriarte

- Grant proposals for the following grants have been submitted:
 - Innovations in Supervision mobile reentry application
 - Innovations in Reentry Pathways Program Enhancement
 - Improving Reentry for Adults with Substance Use Disorders partnership with the Sheriff's Office

Saelee, Linda

- Comprehensive Opioid, Stimulant, and Substance Abuse Site-Based Program (COSSAP) to support the Collins Drive Residential Multi-Service Opportunity Center – Grant is in progress, FY 2020 Competitive Grant Solicitation
- Prop 64: Prevention and Social Awareness Grant in progress, due in June; will circle back with partners
- Grants not awarded until end of September
- <u>Discussion</u>:
 - Environmental Grant revisit use of pesticides in illegal growths; large grant
 - Follow-up with the District Attorney' Office regarding grant extension
 - Releases from prison and jail mental health provider

<u>Housing Update</u> – Jeannette Rodriquez

- Temporary Housing
 - Men of Valor Academy (MOVA): 35 beds
- Transitional Housing (83 beds)
 - Bay Area Community Services (BACS) Holland Project in Oakland: 10 single occupancy rooms
 - Building Opportunities for Self Sufficiency (BOSS) Hope Project: 15 beds; dormitory style.

- Dream Center/Kingdom Builders in Oakland: In the process of accepting new referrals; between 26 and 39 beds in shared living space.
- 7th Step Foundation in unincorporated area near Hayward: In the process of accepting new referrals; 32 beds. Expect to be up and running mid-May.
- Rapid Re-housing (permanent housing) short-term subsidy support clients secure long-term permanent housing as tenant
- There are other housing interventions in the pipeline in recognition that the need exceeds the current resources available
- 350 people are being served with rapid re-housing; 492 households (July through end of April)
- Discussion:
 - Emergency Operation Center: on 40th and Telegraph in Oakland. Hotel room beds; early releases
 - Accessing needs: no/limited dedicated beds for females, mentally impaired, sex offenders or disabled

 - Probation is at maximum capacity for handling contracts, RFPs, etc., due to staff shortage
- Action

b. Behavioral Health RFP Update

- Seriously Mentally ILL: contract negations in progress with Felton
- Mild-to-Moderate: contract through 6/30/22; for Center of Reentry Excellence (CORE), Roots will work in North County and Felton in South County
- RFP Augmentation: Currently, there are a number of contracts relative to services; new RFP's to expand services or augment program that already exists
- Action
 - Convene a meeting with ACBH and Probation to map out the behavioral health system and invite Eric von Geldern

FY 20/21 Funding Discussion and Action

- a. Motion approve \$3,625,000 in Realignment funding for FY 20/21. Motion passed.
