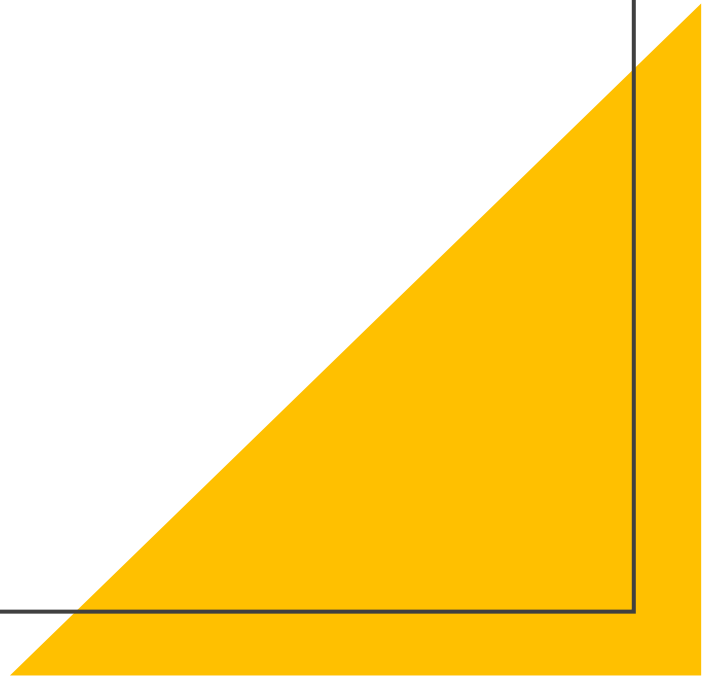

# Purpose

---

- The goal of the coordinated reentry services program (CRSP) is to ensure all clients have an opportunity to create a thorough, holistic, multi-phase reentry plan to support their long-term success, and they are personally connected to coordinated services that meet their individual goals and needs laid out in their plan. Throughout the supervision term, CRSP should support clients in updating their reentry plans to accommodate changing goals and circumstances. As a single-entry point for all Clients, CRSP is also intended to increase Client's awareness of services relevant to their needs and increase service coordination and utilization amongst clients.
