JJCPA & YOBG

- The Juvenile Justice Crime Prevention Act (JJCPA) program provides state funding for counties to implement programs that have proven effective in reducing crime and delinquency among at-risk youth and youthful offenders.
- The Youthful Offender Block Grant (YOBG) program provides state funding for counties to deliver custody and care (i.e., appropriate rehabilitative and supervisory services) to youthful offenders who previously would have been committed to the California Department of Corrections & Rehabilitation, Division of Juvenile Justice.



Role of the Juvenile Justice Coordinating Council (JJCC)

- Welfare and Institutions Code (WIC) § 749.22 requires counties to establish a JJCC
- Chaired by Chief Probation Officer
- Assess existing services and resources for justice-involved & at-risk youth and their families
- Prioritize communities with high rates of juvenile crime
- Develop strategies for prevention, intervention, suppression responses to juvenile crime & delinquency
- Develop information sharing systems for better cross-sector communication
- Review annual JJCPA & YOBG combined plan



JJCC & SB 823 Subcommittee

- Welfare and Institutions Code (WIC) § 749.22 requires counties to establish a JJCC.
- Shall develop and implement a continuum of county-based responses to juvenile crime.
- Shall include the Chief Probation officer, as chair, and one representative each from the District Attorney's office, the Public Defender's office, the Sheriff's Department, the Board of Supervisors, the Department of Social Services, the Department of Mental Health, a community-based drug and alcohol program, a city Police Department, the County Office of Education or a school district, and an at-large community representative.
- The Juvenile Justice Subcommittee has been established under Senate Bill 823, which began the closure of the state's Division of Juvenile Justice (DJJ), realigning state functions to county governments. Members of the subcommittee will assist in the development of a comprehensive long-term realignment plan to serve youth at a local level, including the identification of facilities, programming, service needs, and the allocation of grant funding.



Plan Deadlines

JJCCPA Annual Plan

- **Due by May 1 of each fiscal year:**
 - JJCPA-YOBG Plans that combine all required information for each of the two programs into one consolidated document.
- **Due by October 1 of each fiscal year:**
 - A JJCPA-YOBG Year-end Report that provides expenditure detail for both JJCPA and YOBG as well as specified county-wide juvenile offender data

SB 823 Plan

- Was submitted to the Office of Youth and Community Restoration (OYCR) on 12/23/2021
