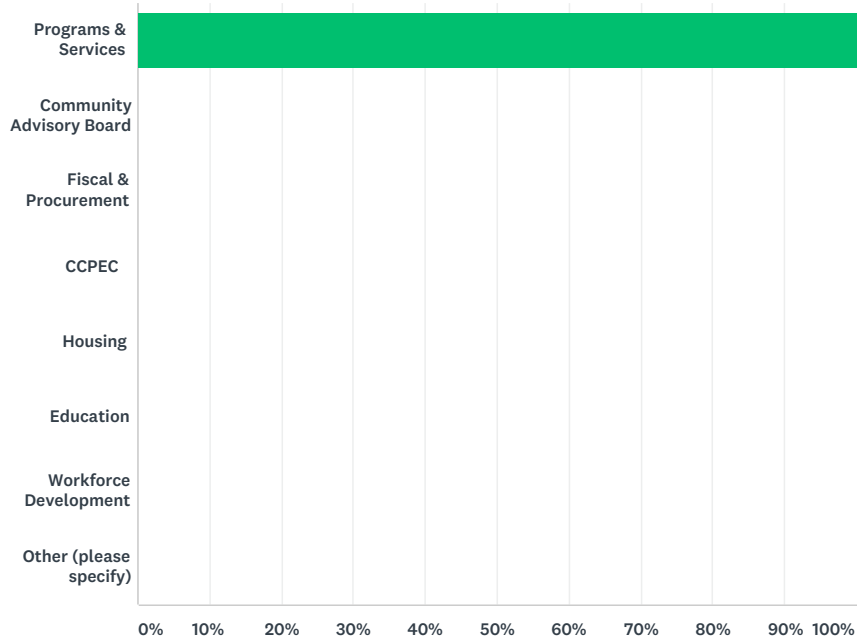

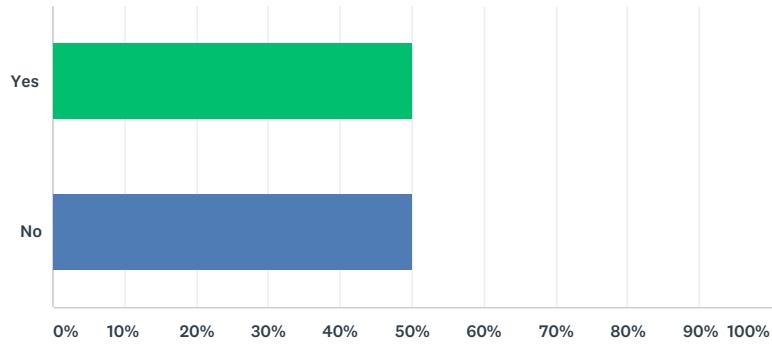

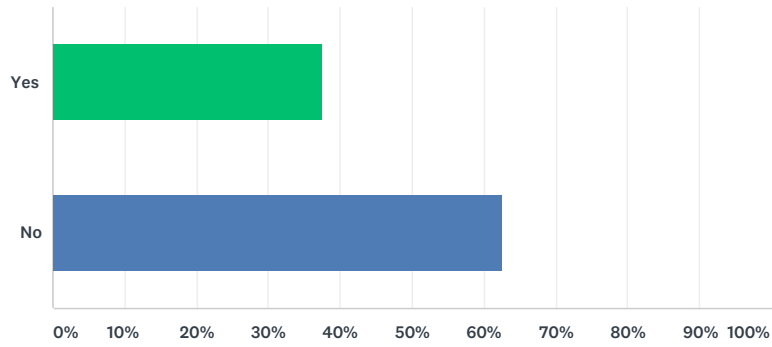

Q4 Do you have a family member who has been incarcerated

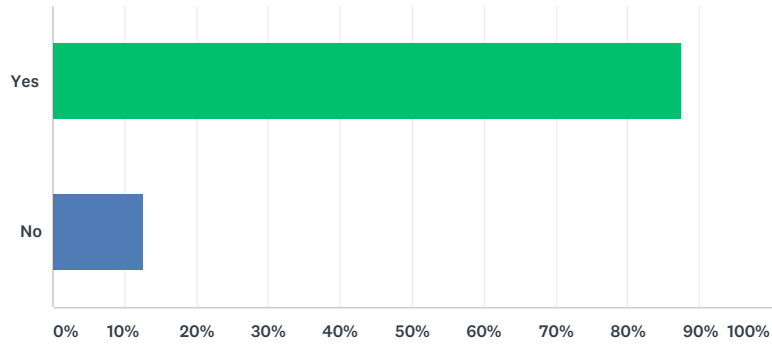

Q5 Do you work for an organization who serves system-impacted individuals

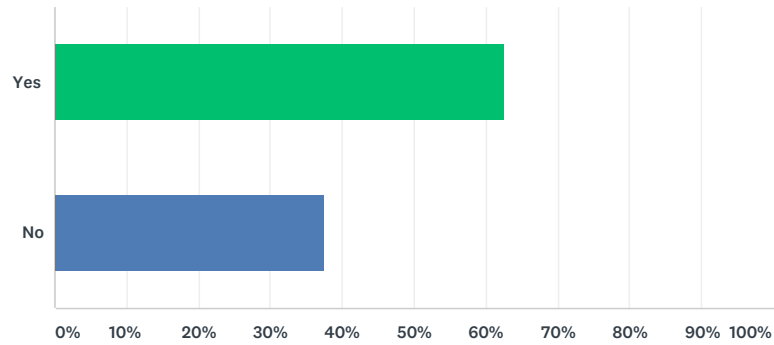

Q6 Have you ever been a victim of violent crime?

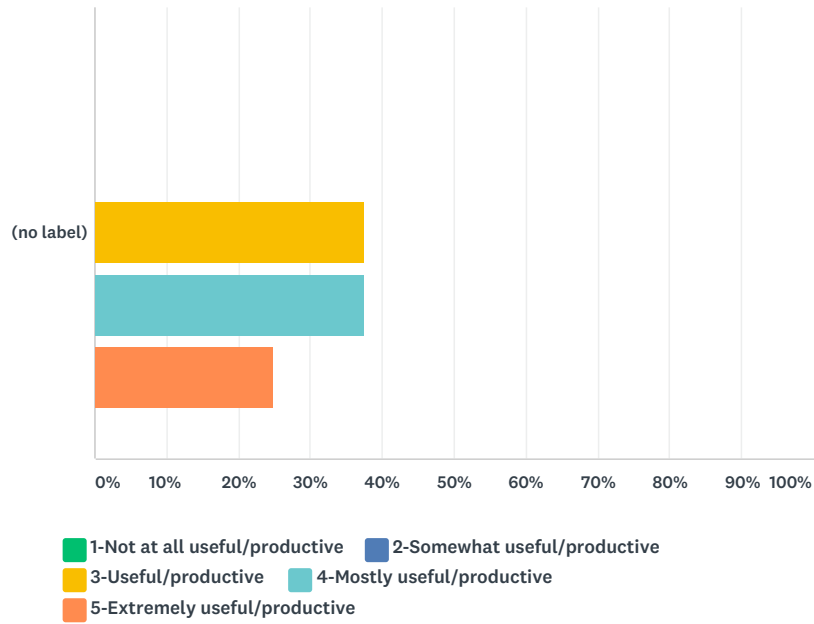

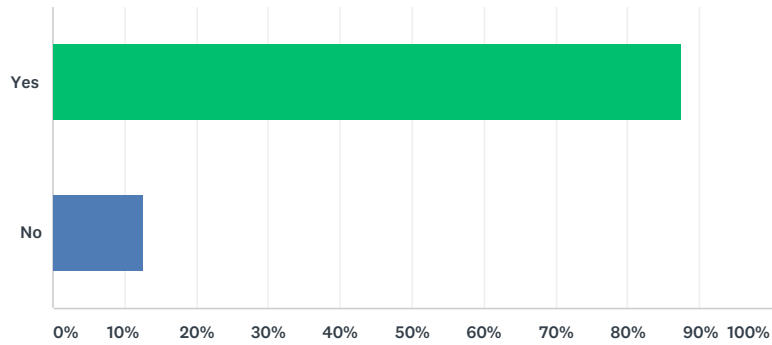
